DESCRIPTION

The Marshall University School of Art & Design invites its faculty, alumni, current students and friends of the department to propose an original work of art for inclusion in the *We ART Marshall* exhibition. This will be the inaugural exhibition for the newly renovated Visual Arts Center located in downtown Huntington, WV. Works that are not placed in the *We ART Marshall* exhibition in the Visual Arts Center gallery will be exhibited elsewhere throughout the building as space permits. The exhibition will open **Thursday, September 18, and run through Friday, November 7, 2014**

CRITERIA

All forms of visual media are welcome. Dimensional works should be able to fit through a standard door opening.

SUBMISSIONS

Proposed works must be submitted digitally prior to inclusion in the exhibition. The digital images will assist in the selection and location assignment for each proposed artwork. Artwork for the exhibition will be curated by a committee composed of faculty from the School of Art & Design, the Gallery Director, and others by invitation. There is no fee required to present images for consideration. All images should be sent in an e-mail attachment to the following address by August 18, 2014: schultzm@marshall.edu. Images should be in JPEG format, 72 ppi, and measure no larger than 1200 pixels on the longest side. Image files should not exceed 2MB. Video samples should be in QuickTime compatible format.

Please label each image with the following information: artist's last name (underscore) first name (underscore) image number. If a detail image is included, please indicate "detail" in the image file title **Example**: smith_john_1.jpg, or smith_john_1detail.jpg

Emailed submissions should also include a printable image list numbered to match the image files.

The image list should include:

Image number

Artist name

Artwork title, Dimensions

Medium/material(s)

Purchase Price without commission:

If there are special installation or display requirements, i.e. pedestals, projection equipment, television screen, etc. please describe any requirements in the body of the submission email.

INSTALLATION CRITERIA

Works must arrive ready to install. The artist is responsible for providing all hanging devices that are necessary in the installation of the artwork (the gallery will provide basic hanging devices such as nails and screws). If complex installation is required, the artist may be personally responsible for the artwork installation. Please contact the Gallery Director, Megan Schultz, at schultzm@marshall.edu to discuss any special exhibition requirements for a particular piece.

EXHIBITION

The selected works for the We ART Marshall exhibition will be displayed in the Visual Arts Center Gallery **September 18– November 7, 2014.** An opening reception will be held on **September 19, 2014 from 4-5 pm**. All other works selected to be displayed throughout the Visual Arts Center's academic spaces will be accessible to the public during the Community Tours on **September 19, 2014** as part of the Visual Arts Center Grand Opening Events. After September 19, works displayed on floors 2-6 will be viewable to students, faculty, and scheduled visitors to the Visual Arts Center.

All works should be available for the duration of the exhibit. If you are unable to meet the digital image or artwork delivery deadlines listed above, but would still like to participate in the exhibition, please contact the Gallery Director for alternative arrangements.

Please note that the Visual Arts Center is a multi-use building and works may be moved to accommodate the needs of students and for special events.

INSURANCE and LIABILITY

The Visual Arts Center (VAC) will exercise every possible care in the safekeeping of loans while in its possession, but its liability to lenders is limited. Please refer to the VAC loan agreement form for further information.

HAND DELIVERY or SHIPPING

The artist is responsible for all costs related to shipping and insurance of artwork while in transit to and from the gallery. Artwork should be shipped in a substantial,

reusable container and include a pre-paid return shipping label. Marshall University will not be responsible for damage due to incorrect packing or an insufficient container. Please address shipped works to:
