- Minutes: Previous meeting minutes were approved without changes.
- Correspondence: None.

COMMITTEE REPORTS:

- **Banner Oversight Committee (BOC)**
 - BOC is trying to determine who owns which security classes.
- **Banner 8 Upgrade**
 - Pat Gebhart proposed holding testing sessions on Banner 8 in DL 349. Pat will reserve the room and email times.
 - Concerns were expressed that Banner 7 function keys do not work in Banner 8. Brent Maynard is testing a fix this weekend and stated that the issue will be resolved by launch.
 - Processes generally seem to be working.
 - Job submissions are timing out after 4 days.
 - Allowing students to apply for graduation themselves is not currently implemented, but it was felt that this would save time and prevent errors.
 - C procedures are still being converted and recompiled. Brent Maynard will advise the group when they are ready for testing.
 - Labor Day remains the Banner 8 launch target.

OLD BUSINESS

- **MyMU/MILO**
 - Some transient and/or inactive students still cannot access MyMU. The cause is still unknown.
 - Multiple subject selection control has been modified with extra help text and is working.
 - Corequisites and prerequisites are not displayed on the online schedule.
 - A remedy for this is in progress but not yet ready for discussion.
 - No future paper schedules will be published.
- **Human Resources/Finance**
 - No report.
- **Performance and Priority issues**
 - No report
- **Multiple PIDM/Person**
 - No report
- **MCTC Issues**
 - Banner and Exchange accounts for MCTC staff have been shut off, but some may have fallen through the cracks.
 - Emails to MCTC staff will be automatically forwarded to their @mctc.edu address.
 - MUNet accounts of MCTC-associated persons with no ties to MU have been terminated. This will break their email.
 - Computing Services is still finalizing overall contracts and SLAs with MCTC.
 - MCTC students retain access to various library facilities (notably borrowing books) but cannot use the computers.
 - Howard Young enquired as to whether MCTC students living in Residence Halls will be able to use hall computing facilities and network infrastructure.
 - They will likely need a 901# as a casual person.
 - Campus wireless networks have separate SSIDs for MCTC students.
 - MCTC students connecting from MU halls will not be able to access internal resources or applications on the MCTC network. Arnold Miller will investigate a solution.
 - After August 14, MCTC advising holds will be removed.
 - New holds may have been added during July. Arnold and Pat are to scan for residuals.
- **Concurrent Curricula**
 - No report.
- **Connect 2 recruitment system**
 - Jan Fox and Gayle Ormiston are studying the Enrollment Management product.
- **Oracle Release**
 - No report.
- **Faculty Information/Digital Measures**
 - Pat and Arnold are making progress despite some confusion over previous communication with the AD's concerning identifying new faculty.

- **Document Imaging/Extender**
 - First training session will be October 26, but this will focus largely on installation. A second session on November 10 or 11 will address end-user training.
 - Five departments have been selected to receive the training.
 - Observers are welcome.
- **Faculty Advisor/MyMU hold**
 - Seems to be working.
 - Not available in MyMU.
- **SSN Masking**
 - No report. On hold until after Banner 8.
- **New PIN proposal**
 - No report.
- **Audit issues**
 - Auditors have not yet sent their draft report.
 - Job monitoring is likely to be a problem.
 - Item can be removed from the agenda and addressed by the BOC.

NEW BUSINESS

- **CIPC Code Table Update**
 - Mike McGuffey and Brent Maynard are working on the changes and will update the group after Labor Day.
- **MAP-Works**
 - MAP-Works is software purchased by the HEPC for 3 state schools including MU.
 - It takes results from student profiles and survey results and attempts to identify which are “at-risk”.
 - The Assessment Office is also asking for ethnicity, residence hall status, college/major information etc.
 - Students will receive email surveys during the third week of the semester.
- **New Student Email System**
 - All incoming freshmen will use the live.marshall.edu email system.
 - Sometime this fall all other students will be converted.
 - It effectively provides an Exchange account with 25 GB of storage per user.
 - 100-200 students are already opting in to the system each week.
 - Mail to @marshall.edu accounts will automatically forward to the new @live.marshall.edu address.
 - Mails from students using the new system will appear to come from the @live.marshall.edu domain.
- **Secretary Rotation**

 - October – Residence Services
