## New Faculty BIOS

## Alumni Spotlight **MAEGAN WILSON**



**Maegan Wilson is a CPA at Hess, Stewart & Campbell, PLLC in Huntington, WV.** She graduated from Marshall in 2011 with her BBA in Accounting. Since then she has passed the CPA exam and has had many opportunities to grow and advance in her career. Most important, she has gotten a chance to use her skills to help the community and support a cause that is important to her as the Treasurer of the Little Victories no-kill

animal shelter in Ona, WV. When asked how Marshall prepared her for her current career, Maegen responded that it provided a great opportunity for her to interact with professionals in the community. She feels organizations such as Beta Alpha Psi are committed to helping students find internships, and the professors provide many ways to network through projects that give students a chance to interact with local businesses. She says, "Having these opportunities gave me confidence when beginning my career. These opportunities also helped me to get to know business leaders in our community."

Maegan strongly suggests that students start studying for the CPA exam directly out of school while their workload is light. Her advice is to stay focused. Says Maegan, "There are many people that I know who struggle to pass because they wait until the last minute to study. Give yourself time to know the

material, not just memorize the material. Stay dedicated and do not give up!"

Maegan also believes that many students (and people in general) have a misconception of accountants as being people who sit behind a desk all day, do their work, and then go home. When first beginning a career in accounting, this may be your life. However, as you continue to grow into your career and get clients of your own, you will learn that much of what an accountant does is forge relationships with people in the community. According to Maegen, yes, you will still have times where you are sitting behind a desk, but much of your day is spent in meetings with, on the phone with, or at the offices of your clients. In addition, accounting is not just math, there is a great deal of reading and writing involved!

## Faculty **RESEARCH**

**Dr. Susan Lanham published a paper this past semester titled:**

*"Reasonable Degree of Certainty" During Expert Testimony.*

The following is the paper abstract.

Abstract: In many U.S. jurisdictions, forensic accountants who testify as expert witnesses are asked during deposition or trial if their opinions were formulated to a reasonable degree of accounting or economic certainty. The reasonable degree of certainty standard also is used on expert witnesses testifying in other disciplines, such as medical, scientific, and psychological. The determination of whether an expert's testimony is reasonably certain is a requirement for admissibility of that testimony, and although the standard is used commonly during litigation, a review of the literature and case law provides no consistent definition of the phrase. This study addresses how judges and justices across the U.S. define and regard the phrase reasonable degree of certainty as it relates to expert testimony. Results suggest agreement regarding the importance of the phrase and its use by expert witnesses, but also suggest inconsistencies concerning the definition or meaning of

the phrase. Most participants agree that an expert's opinions must be reasonably certain to be admissible, and that the phrase lacks a consistent definition. A gap exists in the literature regarding the definition and importance of the phrase reasonable degree of certainty, resulting in broad variations in the way the phrase is interpreted and used in the legal profession.

## Faculty ACTIVITIES

### Continuing Professional Education Offered

In conjunction with the Huntington Chapter of the West Virginia Society of CPAs, two of our faculty members led continuing professional education sessions this semester. Tessa Carr gave a four-hour ethics seminar in November. The materials were very informative about the AICPA ethics criteria. Tessa used several fun and interactive activities including Ethics Bingo, Family Feud, and Scenario Justifications to keep the attendees involved and engaged. The session was held at Fat Patty's in Huntington and concluded with a buffer lunch.

Dr. Parporn Akathaporn gave a one-hour seminar in December on the new standard ISA 700 (Revised), "Forming an Opinion and Reporting on Financial Statements". In this presentation, she summarized the new ISA auditor's report in comparison to that of the US audit report, and discussed how auditors are supposed to obtain and present the information required by the new reporting standard. This session was held at the Cellar Door as a "lunch and learn" on December 12, 2017.

Parporn Akathaporn also presented a six-hour seminar in Thailand last May. This presentation provided retail investors an in-depth analysis of the financial statements of highly publicized companies listed on Thailand's securities markets. Her presentation covered how to recognize when a company is "window dressing" its financial statements, and how the new auditor's report, which is similar to the new auditor's report prescribed by the International Standards on Auditing (ISA 700 (revised)), can be used to improve investment decisions.

### Division and College Research Workshops

On October 4 and November 1, the Division's faculty met to share research in progress. The presenters were:

**Dr. Junwook Yoo**- Progressive Income Taxation and Investment Risk-Taking: Analytical Approach

**Dr. Chuck Stivason**-Using Scenarios to Understand Users' Information Security Practices Intention

**Dr. Casey Baker**-Unclean Hands and (Not Actually) Legal Cannabis: A Word of Caution to Prospective Investors

These research workshops give faculty a chance to get comments and feedback on their research ideas. It also stimulates ideas for other collaborative research projects.

On November 10, the Lewis College of Business celebrated its inaugural "Research Day". This event provided an opportunity for our faculty to present their current or recently completed research projects. The event was organized by the LCOB Faculty Development Committee, which Tessa Carr our new faculty member serves on. It featured three of our Division faculty: Dr. Jean Price, Dr. Nancy Lankton, and Dr. Junwook Yoo. Drs. Nancy Lankton and Jean Price were runners-up for the best presentation award.

### New Director of the MS Accountancy Program

Marshall University's MS in Accountancy offers our students a path to CPA eligibility by delivering an advanced accounting curriculum and helping fulfill the 150 hours of college credit most states require. Dr. Susan Lanham was named Director of the MS Accounting program this fall, and has been busy implementing several new initiatives. She has contacted every student with junior and senior status and a declared major of accountancy with information on our 3+2 program and its benefits. She also created brochures and posters for marketing purposes using photos and information obtained from recent graduates of the program, and she set up a table at our Meet the Professionals event where information was provided to interested students. She also created an Exit Survey and sent it to all MS Accounting students graduating this semester. Our goals for the MSA program are to double enrollment within two years, make the program easier to complete for our working students by offering courses predominately at night, mentor every student within the program, and create an effective system where the progression of current and prospective students and graduates of the program can be tracked.

*Dr. Jeff Archambault:*  
**PROMOTED TO ASSOCIATE DEAN  
FOR ACADEMIC PROGRAMS**



As of September 1, Dr. Jeff Archambault was promoted from Division Head of Accountancy/Legal Environment to Associate Dean for Academic Programs. We interviewed him to find out more about his new position.

**Q: What are your responsibilities as Associate Dean for Academic Programs?**

A: My responsibilities include managing student issues, working on enrollment growth, and improving the operations and quality of our programs.

**Q: How is the Associate Dean position different from being Division Head?**

A: Instead of just the Division of Accountancy and Legal Environment, I'm responsible for the entire College of Business. One major difference is the coordinating among division heads; for example, five years ago I wrote the Graduate Program Review for the Accounting Department. Now I'm the one collecting program reviews from the various department heads.

**Q: What similarities do you see in the positions?**

A: I have similar duties but over a broader group of people. I still teach one class per semester and am involved in mentoring.

**Q: What are your goals as Associate Dean?**

A: I would like to improve interdepartmental coordination and strengthen things like double majors with 4-year plans. I want to address some recruiting issues. For instance, the emphasis on STEM in high schools can hurt business programs. I want to build connections between Business and other areas of study. The emphasis is on change and where the program is going. My end goal is to make this a better program.

**Q: What do you like most about your new position?**

A: I'm excited about having time to start a new research project. I also look forward to coordinating the business programs.

**Q: What do you miss most about your old job?**

A: I miss being in the classroom. I'm not as tied in to the daily work of teaching, I'm less in tune with the Accounting division. In administrative positions, you get further removed from the field and the teaching process.

**Q: What prepared you to take on this role?**

A: A lot of it started with the MS of Accountancy program. From drafting the proposal to where it is now, I got to know a lot of people. I think it was building those connections that led to my being the Division Head at the time and now ending up here.

**The Fall 2017 Accounting Advisory Board Meeting was held on Friday, November 3.** Members attending were Rachel Burdette, Barry Burgess, Shayna Chapman-Burris, Drema Foster, Jered Green, David Hill, Ray Langdon, Anna Neil, Jay Porter, Melissa Price, Akia Rice, Patrick Smith, J.R. Yost, and Robert Simpson, along with the Division faculty and guests. One topic discussed was Community-Based Learning with Damien Arthur, the Director of Community-Based Learning. The Board helped us think of ways to identify, develop, and coordinate student-client-based research projects. The faculty also led discussions about MS Recruiting and Student Mentoring, with the Board giving valuable input about ways to improve these processes. Dr. Casey Baker presented his ongoing research project about how professionals can help clients deal with the differing Cannabis laws. We also discussed the prospect of requiring a second tax course for undergraduate majors so when they obtain their accounting degree they will have the necessary courses to sit for the CPA exam in West Virginia.

The meeting was concluded with an update of Beta Alpha Psi from Tatyana Hall, the Beta Alpha Psi President, and lunch at the John Marshall Room. We thank all our Advisory Board members for a very successful and informative meeting! Plans are to hold a second Advisory Board meeting in late April 2018.
