Courses Taught

Marshall University

Rhetoric of Collective Memory

Responsibilities: This course examines the rhetoric of collective memory by focusing on how the past is constructed to serve the present. Students learn principles of visual rhetoric in the analysis of public memory places.

Listening and Feedback

Responsibilities: This course examines the art of rhetorical listening in historical, theoretical, critical, and practical contexts. Students learn principles of rhetorical silence, spectacle, oral history narrative, and feminist pedagogy.

Persuasion

Responsibilities: This course introduces students to the understanding, practice, and analysis of rhetorical persuasion in the media age. It focuses on mediated audiences, visual images, culture, political campaigns, and social movements.

Political Communication

Responsibilities: This course investigates the functions, ethics, responsibilities, and social impact of oral communication in periods of social unrest and/or political change.

Professional Presentation

Responsibilities: This course is designed to meet present and future demands of skilled presenters. It focuses upon advanced oral presentation skills, computer assisted/aided presentations, teleconferencing, and other presentational skills.

Intercultural Communication

Responsibilities: This course focuses on barriers to communication across cultures and on strategies for addressing these problems. It highlights understanding how meaning is culturally constructed and how individuals can analyze and celebrate cultural differences.

Oualitative Research Methods

Responsibilities: This course provides an introduction to the breadth of qualitative research methods and their application in communication studies. It reviews the diverse methods available for inquiry, with a focus on narrative and metaphorical analysis.

Oral Communication: Principles and Practices

Responsibilities: This course introduces students to the basic principles in oral communication. It focuses on the principles of verbal and nonverbal communication, group communication, listening, interviewing, generating informative briefings, and performing persuasive speeches.

Critical Thinking and Speaking

Responsibilities: This course introduces students to the theory and practice of persuasive discourse analysis and composition. Students learn research techniques, logical and rhetorical conceptions of argument, and technical principles for persuading in public venues.

Argumentation and Debate

Responsibilities: This course develops skills in public oral argumentation. The general course teaches the fundamental principles of reasoning, analysis, and evidence preparation of debate briefs and presentation of standard academic debate.

Life Skills for Student Athletes

Responsibilities: This course assists student athletes in acquiring the necessary skills to master college athletic life, especially social and academic challenges.

Responsibilities: This course teaches students a variety of journalism topics, including editing, reporting, ethics, and law. It provides a feedback mechanism for student journalists, who receive oral and written evaluations of their most recent articles.
