INSTRUCTIONS

For Master's Thesis Agreement Form

Please complete this agreement carefully, so that your master's thesis can be published as rapidly as possible. Please type or print, and look through the following instructions for explanations concerning the Agreement Form. A completed sample form is provided on page A4.

ITEM 1: Full name. This should be identical to the name on your title page, since your name will be used to access your thesis in the database.

ITEM 3: Future mailing address. This is the address at which you can be reached after you have completed your degree requirements. It will be used in mailing any royalties due from the sale of your thesis.

ITEM 4: Please enter university name, plus college or department within the university. For example: Harvard University, School of Divinity.

ITEM 8: Thesis title. The words used in the title of your thesis are the access points for researchers who may use computerized keyword searching techniques to identify works in various subject areas. The words in your title should be selected carefully to represent as accurately as possible the subject content of your thesis.

The published title will be upper/lower case. To ensure accuracy, the author should include all appropriate accents or diacritical marks.

Authors of scientific and engineering theses should use word substitutes for formulas, symbols, and superscripts or subscripts, Greek letters, etc. For example, "Metabolic relationships of P_i and K^+ uptake mechanisms in snap bean (*P. vulgaris*) roots" should be written "Metabolic relationships of inorganic phosphate and potassium uptake mechanisms in snap bean (*Phaseolus vulgaris*) roots."

ITEM 9: Additional keywords. If retrieval of your thesis would be enhanced, you may add up to five keywords. For example, geographical locations or scientific names not mentioned in your title or abstract might be listed.

ITEM 10: Thesis subject category. Select from the "Subject Categories" list on page A5 of the booklet the category related to the discipline and content of your thesis, under which you wish to have your abstract published. Enter the corresponding four-digit code and the category name. If you wish, you may indicate additional subject codes and categories that would enhance electronic retrieval.

ITEM 12: If you wish UMI to file, on your behalf, an application for registration of a claim of copyright for your thesis, please answer item 13 and complete the "Authorization to Apply for Registration of My Claim to Copyright" section on page A7. The certificate of registration will be mailed to you by the Copyright Office approximately five months after UMI receives your thesis for publication. This service is available only for authors publishing their theses with UMI.

Master's Thesis Publishing Agreement

Through my graduate school, I agree to supply you, UMI Company (UMI), with my paper master's thesis and with an abstract of 150 words or less.
