#### **JOB SUMMARY**

The Academic Laboratory Manager II manages the operations of an academic laboratory, to include ensuring the proper material, supplies, and equipment are ordered and that all stores, equipment, and furnishings are kept in good repair.

#### **NATURE OF WORK**

The Academic Laboratory Manager II functions as the second of three levels of an Academic Laboratory Manager, responsible for managing the operation of an academic laboratory, which includes ensuring the adequate supply of necessary materials and the proper use and conditions of equipment and furnishings. Additional responsibilities include supervising and directing the work activities of all assigned laboratory support staff and/or student employees, as well as ensuring the proper training of and procedures for the laboratory to maintain the health and safety of all students and personnel. Job responsibilities require excellent communication and interpersonal skills, as well as the ability to manage infrastructure and material resources such as equipment, chemicals, specimens etc. Work is performed under limited supervision, through the use of specialized tools and established standards. Problems faced in this position are varied, complex, and occasionally ill-defined, requiring some analysis or interpretation of the situation. Errors could easily result in substantial costs, inconveniences, and disruption of services within the affected area.

## **Distinguishing Characteristics**

#### Essential Functions

Establishes, implements, and monitors laboratory policies and procedures.

Manages all assigned personnel and/or student workers, which typically includes recommendations for hiring, firing, performance evaluation, training, work allocation, and problem resolution.

Ensures lab operations are efficient, effective, and comply with established procedures

Ensures lab users have been trained on the correct use of the lab equipment, in addition to mentoring and disciplining lab users for not following safety policies/procedures that have been established for the lab.

Oversees laboratory safety and ensures that the laboratory remains in compliance with all local, state and federal regulations. In cases where non-compliance is found, documents the instances as well as how they were abated.

Schedules safety training for new lab users and retraining for lab users who are in need of refresher training to include but not be limited to: equipment training, safety training and/or lab safety plan reviews and ensure the training has been documented.

Ensures all reagents and supplies are available when needed.

Reviews research protocols of internal and external research groups in an effort to stay abreast as to what research projects are occurring in the lab at any given time.

Communicates and enforces laboratory safety rules to internal and external researchers working in the lab.

Performs other job related duties as assigned.

Performs other functions as required or assigned. Also complies with all Policies and Standards.
