Whenever you leave the U.S. for a temporary trip, the Office of International Student Services takes great care to be sure that you have all of the documents and signatures you need to return. We will check to see if you will need to apply for a new visa before you return, and if there are any reasons why you might have difficulty in obtaining one. Please answer the following questions carefully. It is very important to us that you have a good trip and that you have no difficulties when you return. When you return to the U.S. you are required to provide International Services with a copy of your new I-94 card and your new visa stamp (if you obtained a new visa during your trip).
