GENERAL ITEMS:

 Project Manual Section 012100 – Allowances: Delete existing Project Manual Section 01 21 00 – Allowances and replace with attached revised Project Manual Section 01 21 00 – Allowances.

ARCHITECTURAL ITEMS:

- 1. <u>Project Manual Section 10 14 00 Signage:</u> New interior signs shall match existing configuration, color, type, etc. Provide one sign for each new interior door plus 3 additional signs of same size and type. Room numbers and copy to be determined in submittal process.
- 2. <u>Project Manual Section 10 44 00 Fire Extinguishers and Cabinets, paragraph 2.03-A:</u> Metal shall be stainless steel to match existing.
- 3. Project Manual Section 01 50 00 Temporary Facilities and Controls
 - a. Paragraph 1.08-A: In the first sentence, omit the words "as indicated". Add the following sentences at the end of the paragraph: "Contractor shall erect temporary partitions at each end of First Floor Corridor 108 to isolate project area from adjacent occupied areas. Prior to cutting openings in wall between Corridor 108 and Exist. Dirty Corridor 108, Contractor shall erect temporary partition in Exist. Dirty Corridor 108 to protect Animal Care environment from dust, debris, and other foreign material. Temporary partitions shall be dustproof and consist of metal studs, sound batts, and 2 layers of 5/8 inch gypsum board."

- b. <u>Paragraph 1.10:</u> Add the following subparagraph D: "Contractor shall access worksite primarily from 3rd Avenue through new doorway into Corridor 134. Work with Marshall University Facilities Planning and Management staff and authorities having jurisdiction to allow temporary on-street parking on 3rd Avenue for loading/unloading."
- c. <u>Paragraph 1.11:</u> Add the following subparagraph E: "Contractor shall work with the authority having jurisdiction to locate dumpster on 3rd Avenue.
- 4. <u>Drawing AD-1.1:</u> Add the following notes under the heading "DEMOLITION SEQUENCING":
 - a. After temporary partitions are in place to protect adjacent occupied areas, Contractor shall begin by cutting/preparing new opening in exterior wall and installing a temporary door consisting of hollow steel construction for access to and from the work site.
 - b. Contractor shall delay work required by Demolition Keynotes 17, 18, and 19 until all other demolition and new work on the First Floor is completed with the possible exception of resinous flooring and other miscellaneous work that will not compromise the Animal Care environment.
- 5. <u>Drawing AD-1.1 Keynote 29</u>: Omit "...and return to Owner" and substitute "and salvage for reuse See Mechanical."
- 6. <u>Drawing A-1.1 Enlarged Plan 1/A1.1</u>: Add the following General Note "Coordinate new walk slope and elevations in the field with Architect. Design intent is to provide 1/4 inch / foot slope away from building; slope stair treads 1/8 inch / foot perpendicular to nosing. Locate and protect existing underground electrical conduit and storm sewer prior to excavation."
- 7. <u>Drawing A-2.1 Interior Wall Type Legend, Wall Types A & B</u>: Metal stud and gypsum board portion rests atop of CMU portion. See Section 1/A-1.2.
- 8. <u>Drawing A-2.1 Interior Wall Type Legend, Wall Type J</u>: At the beginning of the wall type description add the following, "1-Hour Fire Rated Partition UL499: " This partition is to be constructed adjacent to the existing partition for continuity of the 1-hour corridor fire separation.

- 9. <u>Drawing A-2.1 Interior Wall Type Legend, Wall Type K</u>: Add "Run to deck and seal for sound attenuation."
- 10. <u>Drawing A-2.1 Finish Matrix</u>: Add a row with the space name and number "108A Passage" with finish descriptions to match those listed for Corridor 108.
- 11. <u>Drawing A-2.1 Holding-2 Space 129</u>: Omit east wall Wall Type "C" designation and replace with Wall Type "B" designation.
- 12. <u>Drawing A-2.1 Keynote 12</u>: Add the following sentences, "All concrete cutting and trenching shall be saw cut in straight lines. Replace and recompact stone base. Replace cut/torn vapor barrier with new; lap/tape and otherwise transition to existing to provide continuous vapor barrier. Epoxy anchor 12-inch long #4 reinforcing bars at 24-inch o.c. maximum staggered along each side of trench edges for anchoring new concrete floor slab. See Drawing S0.1 for other notes."
- 13. <u>Drawing A-1.2 and A-2.1 Architectural General Notes</u>: Add the following Note 7, "Existing steel structure is protected with 1-hour spray-on fireproofing. Where anchorage to existing steel structure is required for new structural steel, hangars, straps, clips, etc., Contractor shall patch fireproofing with similar materials to restore existing fire protection. See Section 07 81 00 Applied Fireproofing." New Interstitial Floor framing is not required to be fireproofed as this area is not a normally occupied space.
- 14. <u>Drawings AD-1.3 and A-3.1:</u> Add the following note: "Remove existing gypsum board ceiling in Space 108K to facilitate mechanical and fire protection alterations required above ceiling. Modify ceiling attachment system as required where new partition is installed. Replace ceiling with gypsum board to match existing; patch and paint walls and ceiling as required."
- 15. <u>Drawing A-4.1 Detail 1/A4.1 Folding Partition Detail:</u> Wood blocking shall be fire-treated as described in Section 06 10 00.
- 16. <u>Drawing A-5.1 Section 3/A5.1</u>: 2-inch rigid insulation indicated shall be mineral fiberboard type as specified in Section 07 21 00.

CONTRACTOR QUESTIONS:

(Emnett Construction)

- No room finish schedule for Passage Room 108a?
 RESPONSE: Same finishes as Corridor 108. See Architectural Item no. 8 in this Addendum.
- 2) Does new exposed ductwork paint? RESPONSE: Exposed ductwork at Interstitial space does not require paint finish. No ductwork is intended to be exposed to view on the First Floor; however, if any ductwork is exposed at the First Floor it shall be painted in accordance with Section 09 91 23 Interior Painting.
- 3) I am sending over Mopec specifications to see if they would be acceptable for the downdraft tables.

RESPONSE: Request is rejected on the following basis:

- a. Specified model is 48 inches long. Proposed substitution is 78 inches long; room size will not accommodate.
- b. Specified model requires 200 CFM exhaust air. Proposed substitution requires 480-640 CFM exhaust air.
- c. Specified model equipped with RO faucet. Could not find on proposed substitution.
- 4) Would the resinous flooring be phased?

 RESPONSE: Phasing of resinous floor installation is Contractor's option.

(Trace Creek)

1) Can you please give a value for the 2yr maintenance bond that is required for the full value of the roofing system? This is located on page 87 of the specifications. RESPONSE: Maintenance bond value shall cover the work associated with this contract and not the entire existing roofing system. Roofing work of this contract is limited to that required to cut in and patch for installation of new rooftop mechanical equipment.

- 2) On Drawing E-1.1 a lighting fixture is shown with a designation of "R6". This fixture is not included on the fixture schedule shown on drawing E-0.1. Will you please provide a part number, catalog sheet or an acceptable replacement to be installed in its place from those fixtures currently shown within the fixture schedule? RESPONSE: The fixture with designation "R6" should be revised to be "R2." There is no R6 fixture type in the project.

Please include the following items in the next addendum issued by your office for the above referenced project.

PLUMBING

RFI Questions from Contractors:

1. Question: "Page P1-1.1 sink P4-2 note 9. Has acid waste pipe to this fixture."

Response: Revise coded note 9 to read, "Install 2" US below slab and extend up in wall to hand sink with hair/solids trap. Extend 1-1/2" vent up in wall to ceiling space."

2. Question: "Spec book section 11-53-00 Page 6 Laboratory Equipment M.4 calls for eye wash for the downdraft workstation. P-2.1 doesn't show TDHW for eyewash run to this fixture."

Response: Extend ½" TDHW piping from Room 131 to drop down in wall to eyewash provided with downdraft workstation.

3. Question: "The PDC series Beacon Medaes gas manifold doesn't match the remarks on the laboratory equipment schedule."

Response: Carbon Dioxide Cylinder Manifold shall be model #PDC1500B-320-4-SSH-VV. Oxygen Cylinder Manifold shall be model #PDC3000B-540-2-SSH-VV. Install in accordance with manufacturer's recommendations.

4. Question: "Does the RO water loop need to be temporarily hooked up during construction of the new one to maintain RO to the labs next to the project?"

Response: Downtime for relocation of RO system shall be kept at a minimum and shall be closely coordinated with the owner.

5. Question: "The specifications call for a fully automatic, cabinet style manifold as opposed to the open style, semi-auto PDC series manifold shown on the schedule."

Response: Refer to Question 3 response above.

6. Question: "The specifications call for use of gas monitors but were not seen on the plans. Beacon Medaes recommends the use of gas monitors in all areas where personnel could be exposed to dangerous levels of gases, particularly in cylinder rooms. Should O2 and CO2 monitors be included, and if so, to what extent. Monitor only, or warning beacons and horns?"



Response: NFPA does not mandate confined space monitoring for manifold rooms. Mechanical ventilation (exhaust) shall be provided in the cylinder room.

7. Question: "The specifications call for use of vacuum pressure regulators but were not seen on the plans. Please clarify."

Response: Vacuum pressure regulators are not required.

ELECTRICAL

- 1. Refer to sheet "E-1.1 Lighting Partial First Floor Plan Electrical"
 - a. Revise corridor lighting fixture type R6 outside room 133a to be fixture type R2.
- 2. Refer to sheet "E-1.2 Power Partial First Floor Plan Electrical"
 - a. Revise room 133a west wall duplex receptacle to be a quadreceptacle.
- 3. Refer to specification section 283111-2.01-A.-1.
 - a. Revise section to read, "Edwards Systems Technology (EST); a part of UTC Fire & Security as furnished by authorized EST dealer."
