Old Business

Senate Bill 73.05

- The Senate felt Funding Bill was not clear and was not funding the organization to the best of our ability.

- The Senate due to improper funding rejected SB 74.14.

Senate Bill 74.18

- SR 74.02 was approved by a role call vote with all senators saying "yay" except one, Reid Palmer saying "nay."

A RESOLUTION

2 **1. To require members of the Marshall University Student Government Association to attend mandatory**
3 **events:**

4 **(a). The advisors of the Student Government Association may require an event mandatory.**

5 **(b). Only 2 events per semester may be deemed mandatory by the advisors.**

6 **(c). Excused Absences:**

7 **(1.) Must be submitted 48 hours prior to the event.**

8 **(a). Unless extreme circumstances occur of which you should notify an advisor.**

9 **(2.) Excused absences are to be submitted to the Judiciary Committee.**

10 **(a.) If the matter is private, submit the excuse to the advisors and inform the Judiciary**

11 **Committee Chair of the submission to the advisors.**

12 **(d). All events deemed mandatory by advisors must be presented with no less than a two week (14 days)**
13 **notice.**

14 **(1.) Notices may be made via weekly senate meetings and email.**

15 **Be it resolved so that SR §74.02 be amended into the Marshall University Student Government**
16 **Association Senate By-Laws under Section six (Office Responsibilities).**
