Accounting Students Join Faculty at State Capitol to Support CPA Legislation

Marshall University accounting students joined Professors Amanda Thompson-Abbott and Amanda Meadows for CPA Day @ the Capitol on Wednesday, January 21, to advocate for legislation that would expand and strengthen pathways to the CPA profession. The legislation, supported by the West Virginia Society of Certified Public Accountants (WVSCPA), aims to improve access and flexibility for future accounting professionals entering the field. The visit provided students with a hands-on experiential learning opportunity, allowing them to engage directly in the legislative process while gaining insight into how public policy shapes the accounting profession and their future careers.

The Senate version of the bill, Senate Bill 532, passed unanimously (34–0) and has advanced to the House Finance Committee, while the House companion bill, House Bill 4088, is expected to be considered by the House Government Organization Committee in the coming week. Faculty emphasized that experiences like this help

students connect classroom learning to real-world professional advocacy and understand the broader role accountants play in business and public service.

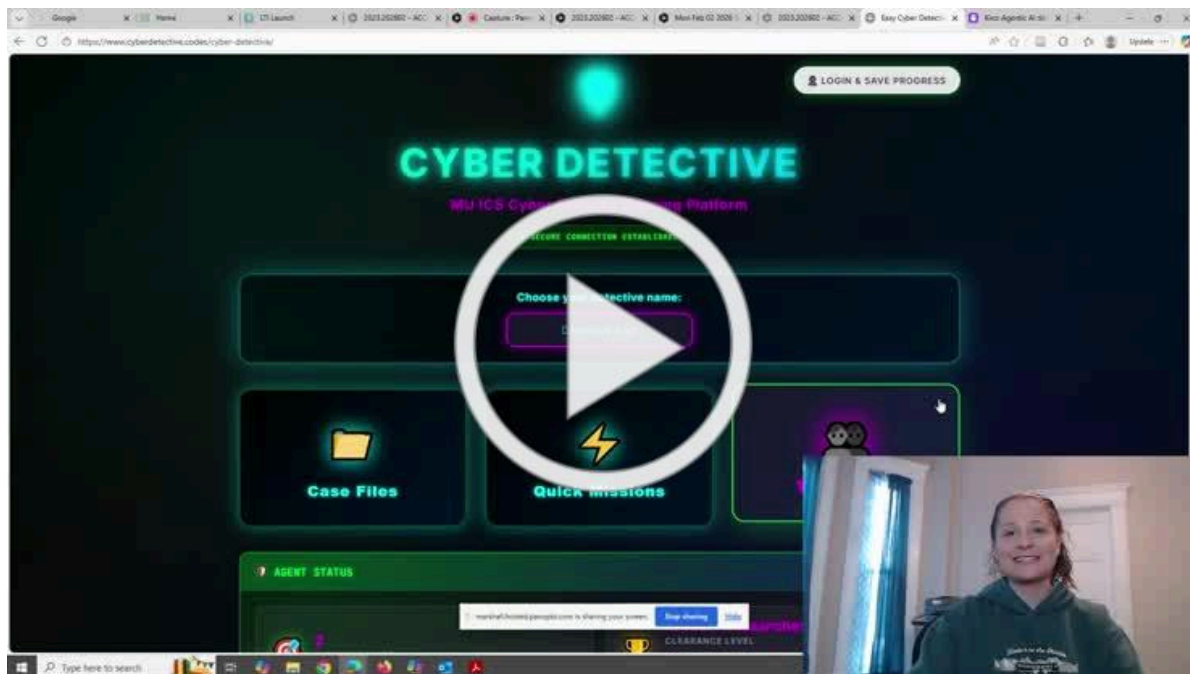
