VITA

Volunteer Income Tax Assistance (VITA) is a program in which our Beta Alpha Psi (BAP) chapter partners with the United Way to prepare tax returns for the underprivileged in the community. The program is coordinated by Josh Ison, our student Vita Coordinator and Amanda Thompson-Abbott, faculty advisor. This semester VITA had approximately 30 student volunteers preparing 210 returns and putting \$140,000 back into the community, free of charge.



He brought surveillance cameras used in their investigations that are hidden inside common objects like key chains. He also brought his bullet proof police vest to pass around the room--it weighs 40 pounds!

FORENSIC ACCOUNTING SPOTLIGHT

An Interview with Dr. Susan Lanham

What is Forensic Accounting?

Any accounting related work that is suitable for use in court.

What do you do in the field?

I work mostly in civil cases and less often in criminal cases. I have been involved in 1000 - 2000 civil matter cases, and only around 10 criminal cases.



In both types of cases, the attorneys on either side call on me to value economic damages such as loss of income potential and future medical expenses, and discount them to present value. I then present this information to a jury if needed.

Why did you choose this field?

I interviewed for many positions but this was the one that clicked and I loved it from the start.

Is Forensic Accounting new?

Forensic Accounting isn't new. However, its popularity has increased in the last 10 years because many universities have started to offer degree programs in forensic accounting. Also, it is gaining more exposure on TV.

Who is looking to hire forensic accountants?

More large accounting firms have a litigation services division, which is typically civil litigation support. In this area the firms typically hire from within the firm. Law enforcement and hospitals are hiring forensic accountants to work on criminal cases.

What is the job market like in WV and surrounding states?

There will always be a need for forensic accountants to value economic damages in civil litigation and to uncover fraud in criminal cases. However, individuals new to the field may need to move to a more urban area to get started. Once started they can move back to WV to get a job that requires experience.

What kind of credentials do you need for this work?

There are no required credentials although it is recommended that you have at least a Master's degree and some professional designation as you will be compared to your counterpart on the other side of the case. A CPA is a preferred designation but CFF (Certified in Financial Forensics) and MAFF (Master Analyst in Financial Forensics) are also desired certifications. Attorneys love for the hired accountant to have a PhD as they love to call you doctor during the case!

FORENSIC ACCOUNTING SPOTLIGHT (Continued)

Get to Know Dr. Susan Lanham



Dr. Susan Lanham is originally from the Tucker County, Canaan Valley, Black Waters Falls area. She received her BBA from Marshall in 1994, her MBA from Salem in 2004, and her PhD from North Central in 2013. She is a CDFA- Certified Divorce Financial Analyst and a MAFF-Master Analyst in Financial Forensics. She has been named the Forensic accounting expert in over 100 separate legal cases and has performed over 1,000 separate evaluations on economic damages. After joining Marshall in 2014, Dr. Lanham developed the undergraduate course that focuses on criminal forensics and the graduate course that focuses on the civil side. She teaches fraud examination, civil litigation, survey of accounting, accounting principles, and first year seminar. Her favorite class is Survey of Accounting because despite the fact it has 50 students, she

enjoys the diversity in the class with a large international presence. On the personal side, Dr. Lanham is married with three children—all boys! Her husband is a federal agent. Her oldest son just got his learner's permit, the next oldest will get his in two years, and the youngest in two more. Dr. Lanham said jokingly, "The next 6 years will be spent terrified in the car!" She loves gardening and looks forward to planting her large vegetable garden in May. She has a twin brother named Steve who flies a helicopter that has a giant saw hanging from it to cut right- of-ways. Finally, Dr. Lanham says teaching is in her blood because her Father was a principal, her Mother taught and was a high school guidance counselor, and her older sister teaches middle school.

FACULTY AWARDS
