## How to apply

Applicants should follow the admissions process described on the Graduate Admissions website: [www.marshall.edu/graduate/admissions/how-to-apply-for-admission](http://www.marshall.edu/graduate/admissions/how-to-apply-for-admission). Applicants also must submit a copy of their resume and must either have:

- An undergraduate degree from a regionally accredited institution with an undergraduate Grade Point Average (GPA) of 3.0 or higher on a 4.0 scale for all previously completed undergraduate coursework
- OR**
- An undergraduate degree from a regionally accredited institution with a minimum undergraduate GPA of 2.5 - 2.99 on a 4.0 scale for all previously completed undergraduate university work and, in addition to the resume, two letters of recommendation. An applicant may also submit additional documents such as a statement of purpose, test scores, etc.
  - The GMAT or GRE are not required to be admitted to the M.S. Health Care Administration degree program.
