• There has been a change to Graduate Certificate of Advanced Studies in Violence Loss and Trauma Counseling (VoLT) to expand it from 15 to 18 hours, adding COUN 555 Crisis Intervention as a required course. Also, edits were made to clarify the admission policies for the VoLT certificate in the graduate catalog.

• Edits to the Graduate catalog regarding admission to the Literacy Education Program and Literacy certificates in order to clarify policies.

• Addition of COUN 578 Creativity in Counseling as an additional elective in the counseling program.

Residency Competitive Grant: Webinar will be held 5/4/2022 to discuss; grants must be submitted by 6/6/2022, grants will be reviewed 6/27-6/28/2022, awards will be announces 7/15/2022

Residency 2 stipends: Residency 2 students receive \$2,000. Valid through 2023. WVDE is working on ways to make residency model financially sustainable. EOY Expenditure Report is required by end of August 2022 from EPP.

National Accreditors: CAEP and AAQEP are both recognized. If EPP want to transition to a different accreditor, please contact Jodi.

WVCAPA-West Virginia Content Area Approval Program: small pilot implemented January 2023; full implementation Summer/Fall 2023. Continue submitted SPAS.

Residency 2 as substitute teachers: Residency 2 students can substitute 10 days/month at placement school; institutions have the option to limit these days; Residency 2 students should be paid as subs with BA degree

Certification Services: Do not sign for programs that you do not offer; 1C form for autism is not signed by IHE only by county; Licensure and Testing Directory has been updated on WVDE site; Candidates cannot have fingerprinting completed prior to application; make sure cooperating teacher and years experience are listed on applications; if cooperating teacher does not have 3+ years, a letter from principal on school letterhead must be attached with recommendation; basic skills test scores do not expire.

CTR: In past, posting was required to hire student in CTR position. Now, if vacancy is created by teacher on medical or maternity leave, student can be placed in a CTR. County should create a posting with the following language: "significant coursework towards the completion of an approved preparation program is preferred."

Discussion Items

1. COEPD News – Dr. Teresa Eagle

Changes in administration at the university level are linking all items to the catalog; cleaning up catalog of courses that are no longer offered or out of date. Recruitment and retention of students is a focus. Grants are being created to geographically link students to teaching positions in hometown. "Grow Your Own" is new initiative from WVDE. It will seek students for teacher education programs while still in high school. Students will finish IHE programs one year earlier than usual. Students are recruited during their junior and senior year. This will be easier for COEPD to control for elementary majors but will work on planning for content specific secondary programs. Six counties currently want to partner with COEPD. This program will take the place of CTE Careers in Education program.
