ADMISSION REQUIREMENTS: In addition to Marshall University's requirements for admission, an applicant must have a bachelor's degree from an accredited institution with an undergraduate Grade Point Average (GPA) of 2.75 or higher on a 4.0 scale. An applicant must be employed as a career and technical center teacher in West Virginia.

STUDENT REQUIREMENTS: All students follow a program Plan of Study and must maintain a cumulative Grade Point Average (GPA) of 3.0. Course credit transferred from an accredited institution(s) must be approved by the program director prior to completion of the Plan of Study. The Plan of Study must be completed for all admitted students within the first semester of enrollment. Failure by the student to return the signed Plan of Study within 30 days will automatically indicate acceptance of its terms.

GRADUATION REQUIREMENTS: Students must apply for graduation by the published deadline in the semester they expect to graduate. All coursework included in a degree program must not be more than seven years old at the time of graduation.
