The 2025 Clery Report, prepared by the Marshall University Department of Public Safety, offers a detailed overview of crime statistics and safety measures on campus for the years 2022, 2023, and 2024. This annual report is mandated by the federal Clery Act, ensuring transparency and promoting campus safety by disclosing campus crime statistics and security policies.

COMMUNITY POLICING

Marshall University employs a community policing strategy, emphasizing trust and open communication between law enforcement and community members. This approach involves active partnerships with students, faculty, and staff to identify safety concerns and develop joint solutions, empowering everyone to contribute to campus safety.

KEY CRIME **STATISTICS**

(2022-2024)

MAIN CAMPUS:

MAJOR CRIMES:

- Violent Crimes: No reported cases of murder, negligent manslaughter, incest, or statutory rape.
- Robbery: 2 incidents (2022), 0 incidents (2023), 0 incidents (2024).
- Aggravated Assault: 7 incidents (2022) occurring on public property, 0 incidents (2023), 2 incidents on campus and 3 incidents reported occurring on public property (2024).

PROPERTY CRIMES:

- Burglary: 8 incidents (2023) on campus with an additional 3 incidents reported at non-campus properties (2023), 2 incidents on campus (2024).
- Motor Vehicle Theft: 6 incidents on campus and 1 incident occurring on public property, (2022), 2 incidents (2023) on campus; 4 on campus incidents, and 2 incidents occurring on public property (2024).
- Larceny: 59 (2022), 68 (2023), 77 (2024) all locations combined.
- Arson: 1 incident (2022).

SEXUAL OFFENSES AND RELATIONSHIP VIOLENCE:

- Rape: 1 case occurring on public property (2022),
 2 cases on campus; 1 case reported in on-campus housing and 1 case reported on public property (2023) and 3 cases on campus and 3 cases in oncampus student housing facilities (2024).
- Domestic Violence: 3 cases (2022), and 3 cases (2023) in all locations combined, 2 cases (2024)
- Stalking: 4 cases in (2023), 2 cases (2024).

ALCOHOL AND DRUG VIOLATIONS:

Drug Abuse Violations:

- Arrests: 82 (2022), then decreased to 6 (2023) all locations combined, 26 violations (2024) all locations combined.
- Referrals for disciplinary action: 16 (2022), 22 (2023) and 32 (2024) all locations combined.

Liquor Law Violations:

- Arrests: 20 (2022), then decreased to 13 (2023).
- Referrals for disciplinary action: 44 (2022), 66 (2023) and 56 (2024)



SATELLITE CAMPUS:

- Medical Sciences Campus: One aggravated assault (2022) one motor vehicle theft (2022), 5 total larcenies (2022-24)
- South Charleston Campus: Low crime rates with no major crimes reported from 2022 to 2024.
- Mid-Ohio Valley Center (MOVC): Low crime rate with no major crimes reported from 2022 to 2024.
- Bill Noe Flight School (Yeager Airport) and Aviation Maintenance and Technology Program (Tri-State Airport): Low crime rate with no major crimes reported in 2023 or 2024.

SEXUAL ASSAULT, HARASSMENT, AND VIOLENCE PREVENTION:

Marshall University offers robust educational programs to prevent sexual assault, dating violence, domestic violence, and stalking. Key initiatives include:

- Bystander Intervention Training: "Step In, Speak Up" program.
- Primary Prevention Programs: For incoming students and new employees.
- Reporting and Support: Confidential handling of reports, support services, and compliance with West Virginia's legal framework for protective orders.
- Rape Aggression Defense (RAD) System: practical self-defense tactics with essential awareness, prevention and risk reduction strategies.

CONCLUSION

Marshall University is dedicated to maintaining a safe and secure environment for all students, faculty, and staff. To achieve this, the university emphasizes community involvement and actively encourages participation in safety initiatives. Key efforts include community policing, educational programs, and robust crime reporting systems.

Public safety is supported by 24/7 patrol services from certified law enforcement officers on both the Main and Medical Sciences campuses, as well as partnerships with local law enforcement agencies at satellite campuses. The MUPD hotline, campus emergency phones, and usage of the anonymous line help to facilitate crime reporting across all campus locations.

Additionally, the university maintains the MU Alert System for emergency notifications and regularly participates in evaluation drills to ensure preparedness. These comprehensive measures reflect the University's commitment to Marshall Creed.

HIGHLIGHTS FOR **STUDENTS**

Safety Tips for Students:

- Stay aware of your surroundings.
- Use well-lit paths and avoid walking alone at night.
- Keep your belongings secure and never leave them unamended.
- Report suspicious activities to campus security.
- Utilize campus safety resources like escort services.

Note:

On-Campus-Defined as: (1) Any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of or in a manner related to the institution's educational purposes, including residence halls; and (2) Any building or property that is within or reasonably contiguous to the area identified in paragraph (1), that is owned by the institution but controlled by another person, is frequently used by students and supports institutional purposes (such as a food or retail vendor).

Non-Campus Building Or Property-Defined as: (1) Any building or property owned or controlled by a student organization that is officially recognized by the institution; or (2) Any building or property owned or controlled by an institution that is used in direct support of or in relation to the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution.

Public Property-Defined as: All public property, including thoroughfares, streets, sidewalks, and parking facilities, which is within the campus or immediately adjacent to and accessible from the campus.
