I am especially proud of our work on AA-16 last term, and this term AA-6, Faculty Conduct Procedures, and Fitness-for-Duty—work that clarifies academic freedom, modernizes promotion and tenure, and establishes due process where it was not clearly defined. We have followed the main rule of scouting: leave the place better than you found it.

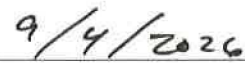

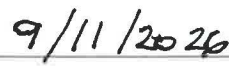
