## MARSHALL UNIVERSITY GRADUATE COUNCIL BYLAWS January 9, 1997 Revised & Approved: October 22, 2004

### Article VIII. Standing Committees

Section 1. Role of Standing Committees

The primary purpose of standing committees shall be to consider and recommend actions and propose policies in the functional areas under their jurisdictions, subject to final approval by the Council.

Section 2. Membership of Standing Committees

a. After consultation with the involved individuals, the Graduate Council Chair shall appoint members to serve one or two academic years as the Chair judges needful so as to maintain continuity and stability within standing committees. One of the goals of this appointment to one or two years is to help provide for a term-balancing of standing committee membership with terms arranged to expire in different years.

b. The Chair of the Graduate Council and the Graduate Dean shall be ex officio and nonvoting members of each standing committee.

c. Each standing committee shall elect its own chair annually.

Section 3. Duties of Standing Committee Chairs

The duties of the chair shall include:

- 1. Scheduling meetings
- 2. Preparing agendas
- 3. Presiding over meetings
- 4. Preparing an annual report

5. Performing other duties as consistent with the efficient management of the committee.

Section 4. Vacancies on Standing Committees

The Council Chair shall appoint members to vacancies on standing committees for the reminder of the academic year.

Section 5. Standing Committees Titles and Responsibilities

- a. Standing Graduate Committees
- 1. Credentialing
- 2. Curriculum
- 3. Academic Planning, Standards, and Policies
- 4. Program Review and Assessment

Section 6. Functions and Membership

- a. Credentialing Committee
- 1. Functions:
- a. Recommends criteria for graduate faculty membership to the Graduate Council.
- b. Reviews graduate faculty membership applications for recommendation to the

Graduate Council.

- 2. Membership: At least three Council members.
- b. Curriculum Committee

1. Functions:

a. Recommends course changes, additions, and deletions.

b. Reviews and makes recommendations regarding additions and/or deletion of degree programs, areas of emphasis, and certificate programs.

c. Evaluates existing courses.

- 2. Membership: At least three council members.
- c. Academic Planning, Standards, and/or Policies Committee

1. Function:

- a. Recommends general policies for admission, progression, and graduation of students.
- b. Recommends general academic policies.
- c. Recommends other policies related to academic area.
- d. Engages in long-range planning and recommends program development.
- 2. Membership: At least three council members.
- d. Program Review and Assessment Committee

1. Function:

a. Reviews annual Assessment Reports submitted by each graduate program

b. Reports its evaluation to the Council for recommendations and actions, after which the Council Chair may report Council recommendations and actions to the University Director of Assessment

c. Engages in long-range planning and recommendations in the area of program review and assessment

2. Membership: At least three council members.

#### PHYSICAL THERAPY DOCTOR OF PHYSICAL THERAPY (DPT)

#### **Program Description**

The Doctor of Physical Therapy Program is a 114 credit professional doctoral program designed to prepare students for entry level practice as physical therapists. All students must have earned a bachelor's degree prior to entering the program. The bachelor's degree can be in any area, however, completion of specific prerequisites is required for admission. This lock-step program which is 3 years (9 semesters) in length begins in May each year with graduation in May three years later. The program contains intermittent clinical exposures/experiences within the didactic portions of the curriculum and 35 weeks of full-time clinical internships. The overall goal of the curriculum is to produce highly competent doctoral level, generalist practitioners.

#### Philosophy

Physical therapy is a health profession whose primary purposes are the diagnoses and management of movement dysfunction, prevention of the onset, symptoms, and progression of impairments, functional limitations, and disabilities, the enhancement of physical and functional abilities, and promotion of optimal human health, wellness and quality of life as related to movement and function. This is achieved through the application of scientific principles through evidence-based practice to prevent, examine, evaluate and intervene in order to alleviate acute or prolonged movement dysfunction and optimize function.

Implicit in this definition is the need of the physical therapist practitioner to assume a number of important roles such as: primary care provider in a challenging health care environment. diagnostician of movement dysfunction; interventionist when applying treatment techniques to restore function; teacher of patients and families; motivator when working with patients and communities to promote optimum health and wellness; team leader and/or participant dependent on the needs of the team and the problem at hand; and a patient, professional and community advocate. In order to fulfill those multiple roles to the highest level, the physical therapist must be committed to service to the profession and the community, dedicated to lifelong learning and the pursuit and application of new knowledge, and devoted to seeking excellence in every avenue of their lives. Therefore, a physical therapy program must pursue an educational process that seeks to help students develop the knowledge, skills, attitudes and behaviors necessary to become proficient in these various roles. The program administration, faculty and staff become role models and guides in the educational process, and a partnership forms between faculty and students in the quest for the pursuit of professional excellence. The faculty accepts the responsibility of emulating professional attitudes and behaviors, and providing leadership to students, and the student accepts responsibility for their own professional growth and development.

The Marshall DPT Program will successfully prepare graduates capable of assuming the myriad of roles implicit in the profession of physical therapy. We will graduate thoughtful and responsible practitioners who will be advocates for the patient, the profession, and the community, and will be capable of assuming responsibilities for addressing the health care needs of a culturally diverse society.

#### Licensure

Once the program has attained accreditation from the physical therapy accreditation agency, schedule to occur in May 2015, graduates of the program will be eligible to take the physical therapy board examination administered by the Federation of State Boards of Physical Therapy. After passing that examination, the student can apply for licensure in the state of their choice (graduates must contact a specific state's Board of Licensure for Physical Therapy to obtain information on the state's eligibility requirements).

The program is currently seeking Candidacy for Accreditation\* status from the Commission on Accreditation in Physical Therapy Education (CAPTE) (1111 North Fairfax Street, Alexandria, VA 22314; phone; 703-706-3245; accreditation@apta.org). Given that approval, the inaugural class will matriculate in May, 2012. In the final semester of the final year of the inaugural class, the program must undergo a full accreditation review in order to move from candidacy to full accreditation status.

#### Admissions Process

International applicants: will be required to submit an official TOEFL score in addition to the other requirements described for consideration. TOEFL iBT score must be consistent with the standards established by the Foreign Credentialing Commission on Physical Therapy (FCCPT) as acceptable for physical therapists desiring to enter practice in the U.S. from a foreign country. The minimum scores to be considered for admission must be a Total Score of 89 with the minimum section requirement of "Speaking" of 26.

#### Academic Policies and Technical Standards

Students in the Doctor of Physical Therapy program are governed by policies stated in the Marshall University Graduate College Catalog. Policies specific to the physical therapy program are outlined in the Doctor of Physical Therapy Student Handbook.

#### **Technical Standards**

Physical therapy education requires that the accumulation of scientific knowledge be accompanied by the simultaneous acquisition of skills and professional attitudes and behavior. The clinical doctorate (DPT) degree, awarded by Marshall University, College of Health Professions, Department of Physical Therapy at the completion of the student's education process, will certify that the individual has acquired a broad base of knowledge and skills requisite for the practice of physical therapy. To this end, all courses in the curriculum must be completed successfully. In order to acquire the knowledge and skills to function in a broad variety of clinical situations and to render a wide spectrum of patient care, candidates for the DPT degree must have abilities and skills in five areas: observation; communication; motor; conceptual (integrative and quantitative); and behavioral/social. Technological compensation can be made for some disabilities in certain aspects of these areas, but a candidate should be able to perform in a reasonably independent manner. The use of a trained intermediary means that a candidate's judgment must be mediated by someone else's power of selection and observation, and as such is unacceptable.

#### Observation

The candidate must be able to observe demonstrations and experiments in basic and applied sciences including, but not limited to human anatomy and physiology, neuroscience, as well as in didactic courses in physical therapy theory and practice for normal and pathologic states. A candidate must be able to observe a patient accurately at a distance and close at hand. Observation requires the use of common sense, as well as the functional use of the senses of vision, audition, olfaction, and palpation.

#### Communication

A candidate must be able to elicit information from patients, describe changes in mood, activity and posture, and perceive and accurately report nonverbal communications. A candidate must be able to communicate effectively and sensitively with patients and their families. Communication includes not only speech, but reading and writing. The candidate must be able to communicate effectively and efficiently with all members of the health care team in both immediate and recorded modes.

#### Motor

Candidates should have sufficient motor function to elicit information from patients by palpation, auscultation, percussion, manual positioning of body segments and other evaluative procedures. A candidate should be able to do basic screening and examination (physiological measures such as HR and respiration), diagnostic procedures (palpation, manual muscle testing, goniometry, sensory evaluation, gait analysis, balance assessment), and evaluate EKGs and X-rays. A candidate should be able to execute motor movements reasonably required to provide general care and emergency treatment to patients. Examples of emergency treatment reasonably required of physical therapists are cardiopulmonary resuscitation, and application of pressure to stop bleeding. Additionally, candidates must be able to perform debridement of wounds and other physical assessment maneuvers, where such actions require coordination of both gross and fine muscular movements, equilibrium and functional use of the senses of touch and vision.

#### Conceptual-Integrative and Quantitative Analysis

These abilities include measurement, calculation, reasoning, analysis, synthesis, and retention of complex information. Problem solving, the critical skill demanded of physical therapist practitioners, requires all of these intellectual abilities. In addition, the candidate should be able to comprehend three-dimensional relationships and to understand the spatial relationships of structures.

#### Behavioral/Social Attitudes

Candidates must possess the emotional health required for full use of their intellectual abilities, the exercise of good judgment, the prompt completion of all responsibilities attendant to the evaluation,

diagnosis and care of patients, and the development of mature, sensitive and effective relationships with patients. Candidates must be able to tolerate physically-taxing workloads and to function effectively under stress. They must be able to adapt to changing environments, display flexibility and learn to function in the face of uncertainties inherent in the clinical problems of many patients. Compassion, integrity, concern for others, interpersonal skills, interest and motivation are all personal qualities that are assessed during the admissions and education process.

#### College of Health Professions

#### Masters Degree in Athletic Training

Rationale: (Add/Delete space as needed)

The MS in Athletic Training would prepare students to enter the profession of Athletic Training with an enhanced knowledge of orthopedic assessment, therapeutic modalities, and rehabilitation focusing on evidence based practice. Once this major is approved, we would seek to become accredited by the National Athletic Trainers' Association (NATA). There are currently only 12 NATA accredited programs in the country. There is not currently an NATA accredited program in West Virginia. The opportunities within the College of Health Professions to allow students to gain knowledge in the field of nutrition and rehabilitation and with the close working relationship that already exists with the Dept of Orthopedics at the medical school, it is a perfect environment for this major. Currently, there are 16 graduate assistant positions through MU athletics and various clinical facilities around Huntington. With this number of athletic training students on campus, the program has a strong foothold to become larger in the future. According to the Bureau of Labor Statistics, employment of athletic trainers is projected to grow 37 percent from 2008 to 2018, much faster than the average for all occupations. Over 70% of athletic trainers currently practicing in the profession have a Master's degree; therefore, the demand of the profession promotes the growth of a Master's in Athletic Training. Current legislative changes in West Virginia (HB 3152 - Athletic Trainer's Registration Act) will require that all athletic trainers' be registered. In order to be registered, the applicant has to be Board of Certification (BOC) certified. Therefore, the demand for certified athletic trainers (ATC) in West Virginia will also increase. As well, growth of the degree will be increased because high schools will be seeking to hire graduate assistants for the athletic training needs in an effort save money with reduced salaries compared to hiring a full time athletic trainer. Also, HB 3152 eliminates persons who were calling themselves athletic trainers under the old state certification path. Therefore, the demand for ATC's will increase.

This area is currently a concentration under the MS in Exercise Science with faculty already in place and no additional funding would be needed.

The Graduate Certificate in Digital Forensics is designed to provide students with knowledge and skills for the identification, collection, preservation, and examination of various types of digital evidence, including basic and in-depth knowledge and skills in digital forensic analysis policy and procedure, forensic analysis tools and techniques, data recovery, and investigation, as well as quality assurance, legal, and ethical considerations important to this rapidly changing field. This Graduate Certificate program does not assume, nor does it require, that the applicant have any experience in the field of digital forensics as the course sequence includes instruction ranging from fundamentals to advanced topics. Successful completion of this Graduate Certificate requires that the student:

- Maintains a cumulative grade point average (GPA) of 3.0 or better in 5 required courses, e.g., FSC 632, FSC 634, FSC 605, FSC 609, FSC 676, with no grade of "C" or less.
- 2. Successfully passes a comprehensive examination which spans these subject areas.

### Admission Requirements

1. Applicants seeking admission to the Graduate Certificate in Digital Forensics program, without admission to the M.S. Forensic Science degree program, should apply to the Marshall University Graduate College as a Certificate/ Professional Development student. Students will be admitted on a competitive basis for fall semester admissions only. Review of applicants will begin March 1 of each year but applicants may be admitted any time prior to the fall enrollment deadline. As a limited enrollment program, student will be admitted on a space available basis.

2. Regarding Digital Forensics, those students enrolled in the M.S. in Forensic Science degree program may choose to complete the M.S. Forensic Science with a Graduate Certificate in Digital Forensics OR the M.S. Forensic Science with an Emphasis in Digital Forensics. Those electing to pursue the Graduate Certificate in Digital Forensics must complete a "Graduate Admissions Secondary Program Request" form. www.marshall.edu/graduate/forms/SecondaryProgramRequestForm.pdf

3. Applicants must submit official undergraduate transcripts to the Marshall University Graduate Admissions Office verifying that the applicant has a bachelor's degree from an accredited Institution of higher learning and a cumulative Grade Point Average (GPA) of 3.0 or higher.

 Applicants must submit their Graduate Record Examination (GRE) scores to the Graduate Admissions Office.

5. Applicants must submit 2 letters of recommendation to the Graduate Admissions Office, on formal letterhead from individuals familiar with the applicant's academic record and moral character. These letters must be signed and dated.

6. Applicants must submit a "Personal Statement/Statement of Purpose" to the Graduate Admissions Office, written, signed, and dated by the applicant, explaining why the applicant believes he/she should be admitted to the program.

Reason for change:

The Registrar and the Graduate College office sometimes get calls from prospective employers who are reviewing a graduate student transcript and need to know if the S or CR grade is equivalent to at least a grade of B. University transcripts usually include a legend on the reverse side which explains grades like S and CR. The MU transcript will for the first time include the explanation in the legend when new transcript forms are printed in the near future. We researched Graduate Council history on the issue and found this text below in the minutes for February 2005. The concern for Graduate Council was transfer of credit but we are also proposing that this change will be helpful to students applying for jobs. We could not find any Graduate Council follow up on its February 2005 meeting so we are asking now that this notation be included in the catalog. The proposed notation for the catalog is exactly what will appear on the MU transcript.

### Other Business February 18, 2005

Larsen initiated discussion of issue concerning "CR" and "S" grades. Dr. Deutsch noted that as currently reported on transcripts, these are problematic for students wanting to transfer graduate credits with a "CR" or an "S" grade. The definitional language on the transcript is currently based on undergraduate interpretations of grading, so that "CR" or "S" means "C or better" work, which many graduate programs will not accept. ### ACCELERATED MASTER'S DEGREE (AMD) Program Proposal

### **Geography AMD**

Rationale: Many non-major undergraduates discover geography (and the potential for employment in the field) as a junior or senior. In many cases, it is too late to change majors and graduate on schedule. A "generic" Accelerated Master's Degree will allow students the flexibility to begin graduate studies in geography early by working with their major advisor and a geography graduate advisor. We are not targeting a specific undergraduate major because our graduate students come from a variety of undergraduate backgrounds such as liberal arts, business, or natural sciences.

Admission Requirements: The AMD requires a minimum undergraduate GPA of 3.30. This exceeds our minimum GPA for entry into the geography M.A. or M.S. programs. The admission requirement for M.S. students to take the GRE is waived for AMD students.

AMD Credits: Maximum credits allowed = 12.

Curriculum: Two examples will serve to show how our "generic" AMD program will work. Example 1: An accounting major has nine hours of Free electives as a senior according to the plan of study on page 109 in the undergraduate catalog. Working with the LCOB advisor, the student would make sure that all major, minor, college, and university requirements had been met. Working with a geography advisor, the student would enroll in nine geography graduate credits during the senior year. Example 2: A criminal justice major has fifteen hours of Free electives as a senior according to the plan of study on page 265 of the undergraduate catalog. Working with the COLA advisor, the student would make sure that all major, minor, college, and university requirements had been met. Working with a geography advisor, the student would make sure that all major, minor, college, and university requirements had been met. SU will offer 23 hours of Courses; all offered through SU psychiatric mental health nurse faculty; Students enrolled in the PMHNP will attend PMHNP classes at Shenandoah University after attending the core graduate courses at Marshall University.

The PMHNP curriculum allows students to attend classes during concentrated times (2 weekends a semester). The remaining weeks of the semester, students are placed with clinical preceptors to apply what they have learned in the didactic portion of the courses(s). Students then return to campus for examinations, or arrange for a proctored examination.

Twenty three credit hours will be transferred from SU to Marshall University.

### **Introduction and Background**

According to Rural Healthy People 2010, health manpower shortages and retention of primary care practitioners are major rural health concerns. The Psychiatric Mental Health Nurse Practitioner (PMHNP) specialty was launched to ease the burden of the severe shortage of mental health services in rural areas by providing PMHNP practitioners and faculty to provide a source of educated nurses to teach PMH nursing to future practitioners. In 2010 Shenandoah University received accreditation by CCNE for its Doctor of Nursing Practice that contains the PMHNP specialty.

The Shenandoah University Division of Nursing firmly believes that collaborations between universities to offer this specialty can strengthen and increase the PMHNP workforce in rural areas. The data below demonstrates this point and uses suicide as an example indicator. Factors that influence suicide rates are alcohol and substance abuse, history of a mental disorder (especially depression), suicidal thoughts, barriers to accessing mental health treatment due to lack of insurance, and unwillingness to seek help due to the stigma of mental illness.<sup>i</sup>

West Virginia Counties Accessible to Marshall University Suicide rates related to MUA/P and Rural Status

West Virginia suicide rates are 3 or more times higher than the HP2010 goal and at least 50% higher than the national average. In 2008, 83% (46/55) of WV counties were designated by HRSA as medically underserved areas and 71% (39/55) of counties were designated as Mental Health Professional Shortage Areas. 63% of West Virginia counties were designated as rural in which a fifth of the population lives in poverty.

### Examples of the need for PMHNP include the following:

- The World Health Organization predicts major depressive disorder (MDD), will be most common human diagnosis by the year 2010. The Office of Applied Studies of the DHHS reported that greater than 50% percent of adults who experienced a major depressive episode in 2004, and during their worst or most recent episode that more than half thought it would be better if they were dead.<sup>ii</sup> An estimated 106,079 U.S. emergency department visits resulted from drug-related suicide attempts.<sup>iii</sup>
- Major Depressive Disorder (MDD) prevalence is greater among minority persons. There is a 57.5% alcohol and drug abuse rate concurrent with MDD and 91% of MDD patients have suicidal behavior.<sup>iv</sup> The SAMHSA data confirm a relationship with depression, suicide, and substance abuse, which requires increased patient access to treatment.<sup>v</sup>
- Rural areas are also disadvantaged when meeting the needs of children with serious mental health problems such as psychosis, which is classified as an ambulatory sensitive condition. "The U.S. Bureau

of Health Professions projects a 100% greater need for child and adolescent psychiatrists and 19% for generalist psychiatrists between 1995 and 2020."vi

The AMA reported that the supply of U.S. psychiatrists decreased by 27% between 1990 and 2002. Their physician staffing industry data indicates that demand for mental health services increased by 16% over that same period. The aging of the psychiatrist population decreases access to mental health practitioners. Almost half (46%) of the more than 40,000 U.S. psychiatrists are 55 years or older.<sup>vii</sup>

### Proposal

The Shenandoah University Division of Nursing offers a Psychiatric Mental Health Nurse Practitioner (PMHNP) specialty consisting of didactic and clinical course content essential to provide psychotherapy to individuals, families and groups within hospitals and community settings. The PMHNP curriculum was developed in 2005, and undergoes continual revision, to honor the interplay between the PMHNP objectives, adult learning theory, and the demographics of the areas served. All of these components fit together to provide a unique course delivery that allows the graduate student to successfully achieve the PMHNP core competencies outlined by the National Organization of Nurse Practitioner Faculties (NONPF). The program of study is designed to provide the necessary knowledge, skills and experiences regarding differential diagnosis, health promotion and psychotropic medication management (prescriptive authority) for the psychiatric mental-health patient. Psychiatric specialty courses involving theory and practicum in individual, group, family, gero-psychiatry, and substance abuse are included. A course in Child and Adolescent Psychiatric Mental Health is also included for those who wish to take the Family Psychiatric Nurse Practitioner exam and prescribe for this age group. This program of study enhances the development of advanced practice nurses that care for vulnerable populations of persons with complex psychiatric mentalhealth and medical care problems who are often underserved. The Graduate Program at Shenandoah University is fully accredited by the CCNE.

According to the U.S. Department of Health and Human Services, Health Resources and Services Administration (HRSA, 2004). The demand for registered nurses (RNs) in Virginia is projected to increase by 43% from 2000 to 2020. (HRSA, September 2004). The national shortage of RNs will increase to 340,000 by the year 2020 (Auerbach, Buerhaus & Staiger, 2007). This shortage of RNs will adversely affect the supply of advance practice nurses such as PMHNPs unless universities develop creative, collaborative initiatives to encourage and expand enrollments. The American Nurses Association (ANA) recognizes the need to prepare nurses for discrete scopes of practice and roles through programs that are accessible, affordable, and flexible, and therefore champions partnerships between stakeholders to establish new education models and partnerships (ANA, 2002). In their October, 2002 *Issues Bulletin*, the American Association of Colleges of Nursing (AACN) supported using strategic partnerships to expand nursing education programs (2002). According to AACN, nursing colleges and universities across the country have developed creative solutions involving collaborative relationships among nursing education programs to increase the number of registered nurses in response to the growing shortage (AACN, 2002). This initiative is one such creative solution.

The Initiative consists of affiliation agreements with other universities to offer PMHNP courses to students enrolled in those universities. Upon completion of their graduate core courses at their home universities and the SU PMHNP courses, the students receive graduate degrees from their home universities and certificates of completion of the PMHNP courses. Upon completion of both curricula, the students are able to sit for their national certification examination. In short, through this Initiative, students may go to the graduate nursing program in the affiliate university and get psychiatric mental health education from SU to become certified PMHNPs.

### Benefits

Since SU is located in the northwestern area of Virginia, it can be difficult to access for nurses who live in other geographic regions of our state. Therefore we are seeking to expand access by creating

collaborative consortiums between our PMHNP track and other schools of nursing. This Initiative provides the opportunity for nursing students from various universities to receive their PMHNP education while still attending their home universities.

### This creative Initiative has the following benefits:

- Students have access to PMHNP education at a lower cost by paying state university tuition for a portion of their graduate education.
- Students have access to PMHNP education by being able to attend the program at a university that is closer to their homes. The PMHNP specialty will require minimal travel to attend the courses.
- 3. Students will be able to obtain a graduate degree in nursing at the university of their choice.
- Universities can add a new program without the costly startup expenses of hiring new faculty, buying new resources, undergoing costly accreditation expenses, or significantly changing their existing programs.
- 5. PMHNP programs can expand their educational endeavors to all areas.
- 6. With creative course delivery design (modular learning, front loading didactic lecture time, and computer communications between students and faculty), there is no added cost for distance education technology.
- 7. It allows for expansion of PMHNP education by using existing state and university resources more efficiently with minimal change in the essential structure or design of the original programs.

Not only does this unique and innovative collaboration promote creative solutions to the nursing shortage, but it also is strategically improve the health of our citizens by increasing access to PMHNPs.

### Considerations

- 1. Accreditation forces necessitate that creative endeavors, such as the PMHNP Initiative, require negotiation only with those universities whose core curricula are equal to or better than that of the core in which the PMHNP program is housed.
- Advising procedures must be thoroughly formulated so that the student experiences a seamless transition throughout the entire curriculum. These procedures must insure accurate and thorough transcript review.
- 3. Missions of the home university and the PMHNP program must be similar.
- Admission procedures must insure that the head of the PMHNP program has input in the admission decision of the home university.

### Summary

The purpose of the PMHNP Initiative is to increase access to PMHNP education by developing articulation agreements between Shenandoah University and other universities. Because the specialty courses of the PMHNP Track are separate from the core, we are in a unique position to allow students from these universities to take core graduate credits at their home university before taking the PMHNP courses at Shenandoah University. Upon completion of these two segments of the curricula, students receive a graduate degree from their home university and a "Certificate of Endorsement" in the PMHNP specialty from Shenandoah University. They are then able to sit for the appropriate national certification examination.

### **Education for the future?**

Within the boundaries of sound educational principles and quality clinical experience, the AACN supports innovation and creativity to facilitate excellence in advance practice nursing education. The PMHNP Initiative represents such an innovation. In the future it is possible that each region could have one or more universities that house a program with the remainder of the universities linked to this program

through articulation agreements. When PMHNP education is expanded geographically there is wider access to PMHNP education for nurses. Citizens in the community will then have greater access to PMHNP's who are culturally competent and, because they are members of their communities, are more reflective of the citizens they serve.

NUR 602 THEORETICAL FOUNDATIONS IN NURSING. Provides students with opportunity to relate a philosophical and theoretical base to concepts and processes inherent in nursing. NUR 604 LEADERSHIP IN NURSING. Explores the theoretical basis for effective leadership in nursing. Emphasis is placed on analysis of leadership, characteristics and behaviors of leaders, and the role of the nurse leader. Credit Hours: 3 (3 credits theory).

PR: Admission to the MSN Program.

NUR 606 ADVANCED NURSING RESEARCH. Provides students with the opportunity to develop a researchoriented approach to nursing situations. Focus is upon the development of a research proposal. Credit Hours: 3 (3 credits theory). (PR NUR 602 or Permission from the instructor).

NUR 608 ISSUES IN HEALTH CARE. Explores and evaluates concerns germane to contemporary nursing. Focus is upon the role of nursing in addressing health issues affected by social, economical, political, and technological forces. Credit Hours: 3 (3 credits theory). PR: Priority given to MSN students. Open to other health care profession students with permission from the instructor.

## Area of Emphasis Component Courses: Collaborative PMHNP Program

NUR 620 ADVANCED PATHOPHYSIOLOGY I Focus is on advanced knowledge of body systems altered by disease and or injury. The body systems or diseases studied will include: cell, cardiovascular pulmonary, digestive, musculoskeletal, neurologic and reproductive across the lifespan. Credit Hours: 2 (2 credits theory). CR/PR: Priority given to FNP students. Open to other health care profession students who have had at least six hours or more of A & P and permission of the instructor.

NUR 621 ADVANCED PATHOPHYSIOLOGY II. Focus is on advanced knowledge of body systems altered by disease or injury including: hemotologic, genes, immunity, cancer, endocrine, renal, urologic and integumentary across the life span. Credit Hours 2 (2 theory). PR: NUR 620.

NUR 622 ADVANCED PHYSICAL ASSESSMENT: Introduction to family-centered primary health care with focus on knowledge and skills essential for comprehensive health assessments, analysis of data, formulation of nursing as well as medical diagnoses, development of therapeutic plans, and implementation of preventative care, health promotion and maintenance activities for all age groups and selected cultures. Emphasis is also placed on advanced anatomy and physiology, the prenatal client, the child bearing family, normal growth and development, and beginning socialization into the family nurse practitioner role. The practicum enables students to apply knowledge and skills in primary care settings such as prenatal clinics, child care centers, geriatric centers, screening clinics, and other primary care centers. Students are placed in areas which will enhance their ability to care for rural and underserved populations. Credit Hours: 5 (3 credits theory, 2 credits practicum, 60 hours minimum.) PR or Concurrent: NUR 602, 622.

NUR 663 ADVANCED PHARMACOLOGY I Focus is on the science of drugs and the application to patient care, across the lifespan. Principles of pharmacology covered are: infectious diseases, fluids and electrolytes, peripheral nervous and cardiovascular systems. Credit Hours: 2 (2 theory). PR: Priority given to FNP students. Open to other health care profession students who have at least six credits of A & P and permission from the instructor.

NUR 664 ADVANCED PHARMACOLOGY II Focus is on the science of drugs and application to patient care across the lifespan. Drugs affecting the: blood, respiratory, gastrointestinal, central nervous, endocrine system, antiinflammatory, antiallergic and immunologic drugs. Credits hours: 2 (2 theory). PR: NUR 663.

### **ATTACHMENT 4**

### Description of the PMHNP Initiative at Shenandoah University

Students enrolled in the PMHNP Initiative will attend PMHNP classes at Shenandoah University after attending the core graduate courses at their home universities.

The PMHNP curriculum is unique, dynamic, responsive and flexible. It reflects the commitment to the student living at a distance from campus. Specifically, the courses are designed to allow students to attend classes during concentrated times (2 weekends a semester). The remaining weeks of the semester, students are placed with clinical preceptors to apply what they have learned in the didactic portion of the courses(s). Students then return to campus for examinations, or arrange for a proctored examination. Refer to Table 1 for a schematic representation of this process.

This schedule allows PMHNP students to immerse in their clinicals without being interrupted by scheduled class times, and "engage in the lived experience" of the PMHNP role. Also, clinical sites can be at a variety of locations in the US, even close to home.

While at their clinical agencies, students communicate with the SU faculty and fellow students via Blackboard, email, and Typhon Group for weekly quizzes, journal delivery and critique, and group case studies. In addition, the PMHNP faculty visits each agency and student a minimum of once during this period. The following table describes the PMHNP Curriculum:

### **PMHNP** Plan of Study

Of the 10 courses in the PMHNP Specialty, four are clinical; six are didactic. Courses are accessed via Blackboard. Classes are delivered in three formats: distance, hybrid distance, and clinical (see above). Clinical experiences are arranged by PMHNP faculty. Efforts are made to keep travel at a minimum.

Clinical experiences provide opportunities for students to apply advanced, specialized nursing knowledge, skills, values, meanings and experiences. Practicum experiences assist in the development of the NP role while under the mentorship of experienced preceptors. In clinical settings, students are given the opportunity to implement critical thinking strategies. Students are expected to analyze and influence health patterns, synthesize health promotion strategies, and provide specialized therapeutic nursing interventions, in partnership with patients to positively influence health. A variety of health care settings are utilized.

## **Psychiatric Mental-Health Nursing Course Descriptions**

### NP599 Applied Pharmacology & Therapeutics

The intent of this course is to assist students in developing knowledge, skills, values, meanings and experiences in prescribing pharmacological agents safely and appropriately for clients who experience commonly occurring illness or for those who need preventive therapy. Emphasis is on the safe and appropriate prescription of pharmacotherapy, client education and monitoring practices regarding the therapy and assessment of therapeutic outcomes. (1 credit)

### PMH645 Psychiatric Mental-Health Nursing: Individual Therapy Theories

The course is designed to assist the student in developing knowledge, skills, values, meanings and experiences associated with positively influencing the lived health experience of individuals with common psychiatric conditions. Select theories regarding health promotion strategies, assessment, prevention, intervention and rehabilitation through individual therapy modalities will provide a foundation for care. *The Diagnostics & Statistical Manual of Mental Disorders:* 4<sup>th</sup> ed. (DSM-IV-TV) criteria will be incorporated. (3 credits)

### PMHL650 Psychiatric Mental-Health Nursing: Individual Therapy Practicum

This course allows the student to apply knowledge, skills, values, meanings and experiences to positively influence the lived experience of individuals with common psychiatric mental health conditions through the modality of individual therapy in community based and hospital settings. Select theoretical frameworks guide therapy to include *The Diagnostics & Statistical Manual of Mental Disorders: 4<sup>th</sup> ed. (DSM-IV-TR)* criteria. (3 credits)

### PMH665 Psychiatric Mental-Health Nursing: Group, Family & Community Theory

The course is designed to assist the student in developing knowledge, skills, values, meanings and experiences associated with positively influencing the lived health experience of families, groups, and community mental health of individuals with common psychiatric conditions and disordered interpersonal skills. Select theories will provide a foundation for family and group dynamics, assessment, and intervention. (3 credits)

## PMHL670 Psychiatric Mental-Health Nursing: Group, Family & Community Practicum

This course provides opportunity for the student to apply knowledge, skills, values, meanings and experiences to positively influence the lived experience of individuals with common psychiatric mental health conditions and disordered interpersonal skills through the modality of family, group and community mental health principles. Select theoretical frameworks will guide therapy approaches. (3 credits)

### PMH685 Geriatric Psychiatric Mental-Health Nursing Theory

The course is designed to assist the student in developing knowledge, skills, values, meanings and experiences associated with positively influencing the lived health experience of a geriatric population experiencing concurrent mental illness and/or cognitive decline. Health promotion strategies, assessment measures, through individual, family and group therapy modalities with this population will be discussed. (3 credits)

### PMH686 Child & Adolescent Psychiatric Mental-Health Nursing Theory

The course is designed to assist the student in developing knowledge, skills, values, meanings and experiences associated with positively influencing the lived health experience of children and adolescents experiencing concurrent mental illness and/or cognitive decline. Health promotion strategies, assessment measures, through individual, family and group therapy modalities with this population will be discussed. *The Diagnostics Statistical Manual of Mental Disorders*, 4<sup>th</sup> ed. (DSM-IV-TR) criteria will be incorporated. (3 credits)

### PMH695 Advanced Nurse Practitioner Practicum in Psychiatric Mental-Health Nursing

The didactic and clinical components of this course are designed to provide the psychiatric mental-health nurse practitioner (PMHNP) with knowledge, skills, values, meanings and experiences beyond the MSN prepared psychiatric mental-health clinical nurse specialist role in relation to differential diagnosis and psychotropic medication management (prescriptive authority). The PMHNP role includes assessment, health promotion, diagnosis, planning, medication management and ongoing evaluation of psychiatric mental-health clients across the lifespan in a variety of settings to include primary care sites. Pharmacotherapy principles and psychosocial factors that influence patients' compliance with, and response to, drug therapy is addressed. The 120-hour practicum applies differential diagnosis and medication management principles to acute and chronic psychiatric clients and fulfills the post-graduate psychiatric clinical nurse specialist clinical requirement for the American Nurses Credentialing Certification PMHNP exam. (4 credits)

### HP576 Substance & Relationship Abuse

This course is designed as an interdisciplinary offering to assist health care profession students in recognition and beginning level interventions in populations at risk for substance dependence and/or abuse relationships. Emphasis is placed on providing interventions that are congruent with age, health status, culture occupation and legal-ethical concerns. (3 credits)

### NP690 Advanced Nurse Practitioner Role Development

The intent of this course is to assist the student in acquiring and applying the knowledge, skills, values, meanings and experiences of the professional behaviors associated with the practice of the advanced nurse practitioner. (1 credit)



Rationale Summary:	We are proposing the attached changes to the MA in Spanish. Most of our edits under program description and admission requirements are for clarity. Our biggest change concerns required courses for the thesis and non thesis options. The current program description requires candidates to take six or twelve hours of online linguistics courses from a Spanish university. We are making those courses optional, and are substituting literature and culture courses taught at Marshall. Our reasons are many. First, the degree as written splits the MA between linguistics courses and literature/culture courses. Most MA programs have students do one or the other area, not both. Our intention is to make the MA more focused, and to make that focus on courses that are listed in our catalogue and that are taught by our faculty. Second, the online courses have been difficult to arrange, and it is not yet clear that students can receive financial aid from Marshall in order to take them. These courses are not listed as Marshall from the Spanish university. Finally, we question the advisability of having one quarter to one third of a degree based on online courses from another university when we have the staff and courses to teach the entire degree at Marshall.
	Apart from the program description changes noted above, we are changing one of our required courses. Instead of SPN 533 or 544 as a required introductory course, we are substituting SPN 506. Our rationale is twofold. First, we no longer have a
	professor whose qualifications are specific to SPN 533 or 544. Second, we feel that an introductory methods and theory course better prepares our students for the study of literature and culture.

#### **Biomedical Sciences**, M.S.

All students are required to meet the general requirements of the Graduate College for receipt of a master's degree. A minimum of thirty-six credit hours is required for a non-thesis degree, while a minimum of thirty-two credit hours is required for the thesis degree. No more than six hours of thesis (BMS 681) may be credited toward the thirty-two hour requirement. Each student will specialize in one of the six areas of emphasis as defined in the program overview. For some years, West Virginia University and Marshall University jointly operated an MPA program from Marshall's South Charleston campus. That program has been closed for three years. We believe that this areas will be well served by offering our adults employed in the public and non-profit sectors

Catalog Description:	The Masters Degree in Public Administration will provide graduate training in academic, research and service to prepare students for leadership positions in public service, both in the non-profit and public sector of society. The core consists of 18 semester credit-hours designed to train students to lead agencies in areas of budgetary development and management; data collection and analysis; personnel training and management; and policy development and implementation. Final written and oral comprehensive examinations are administered to all candidates by a committee of three members of graduate faculty in the candidate's program of study. This group would also benefit from the AMD as they receive a more solid education and preparedness but "lose" only one year.
Admission Requirements	The students need to fulfill the same requirements as regular MA students. However, they have the first semester to fulfill all requirements.
AMD Credits:	The students can take up to 12 credits in split 400/500 level courses. AMD candidates need to enroll in the 500 level sections.
Curriculum:	Our MA program requires 33 credit hours plus thesis hours (or 36 credit hours plus problem report hours.) We offer only about 18 credit hours at the 600 level. The remaining hours are split 400/500 level courses. AMD candidates can enroll in these split courses and, therefore, fulfill all requirements of the BA.
