Program Review & Assessment Committee Business: All GC reviews of posted annual assessments were completed. Two assessments were not submitted by their colleges.

Credentialing Committee Business: Sottile stated the SOM audit is in progress and all others have been completed. Ron Childress will receive the South Charleston Graduate Advisor Award. The recipient of the Huntington award is being determined.

Miscellaneous Business of the Council: 1) Christofero urged Graduate Council members whose terms are expiring to remind their respective Deans that elections must be held soon. Newly elected members will be invited to join current members at the last meeting (April) of the academic year. Officers will be elected at the April meeting.

2) Christofero raised the issue that since there are two new colleges, GSEPD and School of Pharmacy, each of the new colleges should have representatives on Graduate Council. In order for this to happen, the GC bylaws may need to be changed; however, any change in the bylaws must be approved by the Board of Governors. It may be possible to add GSEPD and the School of Pharmacy to the list of colleges since the bylaws state each college should have one representative. In the fall, GC can look at the bylaws regarding the current at-large allocation of representatives for the South Charleston campus. Christofero charged the Academic Planning, Standards, & Policy Committee to look at the process and possible changes and determine how this will impact the four at-large representatives. Christofero also recommended GC examine the bylaws from beginning to end in the fall as they have not been reviewed for many years.
