#### The deadline for open enrollment is May 15<sup>th</sup>

#### **PEIA PPB Plans**

#### All PEIA PPB Plans Active employees and non-Medicare Retirees:

- No rate increases in medical premiums for 2023
- The Pharmacy Third Party Administrator will change from CVS Caremark to Express Scripts on July 1, 2022. If you have prescriptions mailed, you will need to change to Express Scripts on July 1, 2022.
- Because of this change, all PEIA PPB plan members will receive new cards. Please make sure that your address is up-to-date with PEIA.
- The new formulary list will be available soon after Open Enrollment begins. Please review the new lists for any change in medication co-pays.
- The carrier for Life Insurance will change to **MetLife** on July 1, 2022. As a result, the rates will change for dependent life insurance.

### The Health Plan HMOs and POS

- The Health Plan will continue to offer three plan designs: HMO Plan A, HMO Plan B and a Point of Service Plan C (POS).
- Copays will not change on all three plans offered by The Health Plan and are the same three plans as offered in 2021-2022.
- Members who choose LabCorp may receive covered lab services at little or no out-of-pocket costs. Find a Lab- Corp location near you at labcorp.com.
- The Health Plan has added <u>Healthiest You</u> by Teledoc as a benefit for all three plans. You may talk to a doctor free by phone or video 24/7.

Get ready for benefits open enrollment! Here is what is changing for your upcoming Mountaineer Flexible Benefits Plan Open Enrollment:

- **Humana/EyeMed** will be the new vision plan provider effective July 1, 2022 and the rates will be lower. Please review your FBMC booklet for more information on rates. As a result, cards will now be issued for the vision plan, although they are not required to obtain treatment. Please make sure your address is up-to-date with FBMC.
- The dental plan, offered through Delta Dental is being enhanced to include posterior composites with the three plans that cover fillings (assistance, basic, and enhanced plans).
- The FSA and Limited- Use FSA contribution limit will now be \$2,850
- The 2023 annual HSA contribution limit for individuals will now be \$3,650.
- The 2023 annual HSA contribution limit for individuals with family will now be \$7,300
