5. Event Type
6. Independent Contractor Information
7. Amount of Compensation

As has been shared in a previous communication, we are releasing a web service that will allow the vendors of the assignment tools your coordinators use to electronically post assignments to the GamePay system, removing the need for manual entry. We have discussed this integration with most of the vendors serving PayOGFE clients. Those vendors will have the opportunity to complete an integration if they choose.

It is expected that some assignments will need to be manually entered into the GamePay system. We are aware that, in some instances, PayOGFE.com may have been entering this information for your organization. While we are happy to continue providing this additional service, there will be an additional charge of \$1.25 for each assignment entered by our staff. We can also assist you in training

your own internal personnel to input this information into the GamePay system. We will anticipate that you will be entering the information on your own, unless you contact us to arrange for assistance.
