AMENDMENT #6

MARSHALL UNIVERSITY

AND

SODEXO AMERICA, LLC

THIS AMENDMENT #6, dated October 27, 2021, is between MARSHALL UNIVERSITY ("University") and SODEXO AMERICA, LLC ("Vendor").

W I T N E S S E T H:

WHEREAS, University and Vendor entered into that certain Contract # MU20DINING effective August 16, 2019, as amended ("Agreement"), whereby Vendor manages and operates the University's Food Services operation in Huntington, West Virginia;

WHEREAS, the parties now desire to further amend the aforesaid Agreement;

NOW, THEREFORE, in consideration of the promises herein contained and for other good and valuable consideration, the parties hereto agree as follows:

1. University has entered into an agreement to lease a point-of-sale system ("POS system") for Marshall athletics for a five (5) year term. University and Vendor have not had sufficient time to finalize all the terms, but wanted to memorialize the intent of each party and will finalize each parties specific responsibilities in a future amendment. The University and Vendor agree to the following:

A. The financial support for the lease of the POS system is described under "Option C" of Schedule 1, attached hereto and incorporated herein.

B. The terms of the lease from Transact shall be in accordance with the terms of the Transact Capital Financing Proposal, attached hereto and incorporated herein as Schedule 2.

C. The Vendor and University mutually agree to the following material terms:

i. Vendor may use a portion of Investment 3, as defined under Exhibit A, Subsection E, number 5, to lease the POS system;

ii. University will reimburse Vendor for monthly fees consistent with Schedule 2 through any combination of a reduction of commissions and intervals of amortization of Investment 3. In the event those amounts are insufficient to cover the monthly fees, then by direct billing to the University for the deficient amount;

iii. Athletics will forego some beer commissions consistent with Option C of Schedule 1; and

iv. University will provide Fifty Thousand Dollars (\$50,000.00) from one of their fund and organizations within thirty (30) days after execution of this Amendment.

D. University and Vendor agree to the above to ensure that the process begins and that Vendor can guaranty delivery of hardware to be ready for the first game on September 11, 2021. See Schedule 3, which is attached hereto and incorporated herein, that lists the equipment to be leased by Vendor.

2. Section 1 is deleted in its entirety and the following substituted therefor:

"1. Description of Services. Vendor hereby agrees to provide exclusive Food Service Operations on the University's campuses located in Huntington, West Virginia, Services or Food Services, defined as the preparation, service and sale of food, beverages, including alcoholic beverages, goods, merchandise and other items at the Premises, specific to the resident dining program, retail program, Catering and concessions, excluding vending, sponsorship agreements and bookstores, and to comply with all Specifications, which may be included in the Proposal Documents. Vendor acknowledges that University has entered into a sponsorship agreement with Pepsi. University shall provide Vendor a copy of any such sponsorship agreement so that Vendor can comply. The University shall use reasonable efforts to direct applicable requests of such Services to Vendor under this Agreement."

3. Section 4.11 is deleted in its entirety and the following substituted therefor:

"4.11 Compliance with Laws, Policies & Procedures. To the extent applicable to the Services, Vendor shall fully comply with all federal, state, local, and University laws, rules, regulations, ordinances, policies and licenses, including applicable building policies and procedures. Vendor shall be solely responsible for ensuring that any recommendations made in connection with the Services comply with all applicable federal, state, local and University laws, rules, regulations, policies and procedures. Vendor shall be responsible to obtain and maintain any necessary liquor licenses and permits for the Joan C. Edwards Stadium and the Hoops Family Field at the Veterans Memorial Soccer Complex and in the Student Center. Vendor shall have the exclusive right to sell and serve alcoholic beverages at the following locations:

Joan C. Edwards Stadium: One John Marshall Drive, Huntington, West Virginia 25755

Student Center: 1W27 Memorial Student Center, One John Marshall Drive, Huntington, West Virginia 25755

Hoops Family Field at Veterans Memorial Soccer Complex: 2598 5<sup>th</sup> Avenue, Huntington, West Virginia 25703

Vendor shall adhere to all applicable federal, state, local laws and regulations regarding the service of alcoholic beverages. Vendor shall not be obligated to serve alcoholic beverages to any person believed by any employee of Vendor to be under the legal age to consume alcohol, and shall have the right, as a condition of the serving of any alcoholic beverage, to require proof of age from any person requesting such service. Further, Vendor shall have the right to refuse service of alcoholic beverages to any person who its employees believe to be intoxicated or otherwise impaired. University shall be responsible to provide security, as necessary, during the service of alcohol."

4. Section 10, Operational Matters, is amended by adding the following as Section 10.25:

“10.25 Alcohol Inventory. Vendor shall purchase and own all alcoholic beverage inventory.”

5. Exhibit B, Subsection A, is deleted in its entirety and the following substituted therefor:

“A. Resident Dining Program. The following meal plans selected by University shall be available to resident dining, commuter and faculty/staff patrons:

1. Resident Dining Plans:

Meal Plan A - 10 meals per week; plus \$500 Flex and 10 Anytime Meals per semester

Meal Plan B - 10 meals per week; plus \$700 Flex and 20 Anytime Meals per semester

Meal Plan C – 10 meals per week; plus \$935 Flex per semester

Meal Plan D – 14 meals per week; plus \$500 Flex and 10 Anytime Meals per semester

Meal Plan E - 14 meals per week; plus \$700 Flex and 20 Anytime Meals per semester

Meal Plan F – 14 meals per week; plus \$935 Flex per semester

All resident students are required to purchase one (1) of the above Meal Plans.

Unused Flex shall roll over from the Fall semester to the Spring semester, provided that the meal plan participant purchases a meal plan for the Spring semester. Any unused Flex remaining at the end of the Spring semester shall be forfeited and shall be for Vendor's account.

2. Commuter and Faculty/Staff Meal Plans.

Meal Plan G – 30 meals per semester; plus \$200 Flex per semester

Meal Plan H – 50 meals per semester; plus \$100 Flex per semester

Meal Plan I – 50 meals per semester; plus \$350 Flex per semester

Meal Plan J – 50 meals per semester; plus \$600 Flex per semester

Unused block meals and Flex shall roll over from semester to semester, year to year, until such time as student is no longer enrolled with University or faculty/staff members are no longer employed by University. Any unused block meals and Flex remaining when student no longer enrolled with University or faculty/staff no longer

employed by University shall be forfeited and shall be for Vendor's account.

3. Meal exchange is available at all retail locations with the exception of the Memorial Student Center. Meal exchange is accepted at the Memorial Student Center concept locations only after 1:30PM.

University grants Vendor the exclusive right to provide University with meals related to meal plans, debit card points and flex points for University to resell to its students, faculty and staff at a specified rate per meal or daily rate."

6. Exhibit B, Subsection B, is deleted in its entirety and the following substituted therefor:

"B. Dining Program Rates. The following dining rates shall be in effect for the 2021-2022 academic year as follows:

Meal Plan A	\$13.31 per person, per day
Meal Plan B	\$14.66 per person, per day
Meal Plan C	\$15.61 per person, per day
Meal Plan D	\$15.35 per person, per day
Meal Plan E	\$16.68 per person, per day
Meal Plan F	\$17.64 per person, per day
Meal Plan G	\$310.44 per person, per plan sold
Meal Plan H	\$318.26 per person, per plan sold
Meal Plan I	\$568.26 per person, per plan sold
Meal Plan J	\$818.50 per person, per plan sold

Rates for the above meal plans are based on a required minimum of two hundred fourteen (214) meal plan days for each academic year and an average minimum number of meal plan participants for each academic semester equal to two thousand sixty nine (2,069) participants. The parties will discuss and review the required minimum number of meal plan participants and propose new language, if needed, for an amendment by December 1, 2021.

Rates for the above Meal Plans include the Flex associated with each Plan."

7. Exhibit B, Subsection E, is deleted in its entirety and the following substituted therefor:

"E. Guest Meals in Resident Dining Facilities. Prices for guest meals purchased in resident dining facilities shall be as follows:

Breakfast	\$ 7.42, plus tax, if applicable
Lunch	\$ 9.34, plus tax, if applicable
Dinner	\$11.00, plus tax, if applicable
Late Night	\$ 6.25, plus tax, if applicable
Brunch	\$ 9.61, plus tax, if applicable"

8. Exhibit B, Subsection I, is deleted in its entirety and the following substituted therefor:

"I. Student Meal Sharing Program. Notwithstanding the foregoing, students who have purchased meal plans pursuant to the Resident Dining Program, as described herein may donate meals for use by "students in-need" as set forth below:

a. Resident Dining Plans. Students who have purchased a Resident Meal Plan may donate up to two (2) of their regular meals, per semester, to the program. Upon donation to the program, the student's regular meals will be reduced by the number of donated meals.

b. Commuter and Faculty/Staff Meal Plans. Commuter and Faculty/Staff Meal Plans are not eligible to participate in this program.

c. Students In-Need Food Bank. The donated meals will be placed in a pool or bank or meals that may be used by "students in-need".

d. Students In-Need. Students In-Need will be identified solely by the University.

e. Donated Meals Exhausted. Should the number of donated meals be exhausted in any given semester, there will be no further obligation on the part of the party to provide additional meals.

f. Donated Meals Expiration. All donations will expire at the end of the semester in which they were donated.

g. University reserves the right to name or rename the Student Meal Sharing Program without the need to modify this Agreement.

h. University will provide the necessary technology support and database information for the implementation and operation of the program."





## PURCHASING AFFIDAVIT

Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**AFFIRMATION:** By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va. Code §61-5-3) that: (1) for construction contracts, the vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.
