# Dr. Mukherjee – Provost

#### • Enrollment & Recruitment

- We've had close to 6000 new first year student applications for undergraduate programs for fall 2023.
- o 149 students attended accepted students day in the College of Engineering.
- Two Green and White Days are scheduled for this semester: February 4<sup>th</sup> and April 1<sup>st</sup>.
- We are in the process of hiring a Chief Enrollment Officer, as Tammy Johnson recently moved to become a faculty member in the College of Education and Professional Development. This person will also hold the title of Vice President of Enrollment Management.
- <u>Glenville State University Visit</u>
  - 25 individuals from Marshall, including deans and President Smith, are visiting Glenville State University that same day.

- Marshall has been helping Glenville to move from a college status to a university status, and we have started a joint nursing program with them.
- Their leadership team will be invited to visit Marshall, probably sometime in May.

#### Mountwest Community and Technical College

- We are working to strengthen our partnership with MCTC.
- We are identifying programs where they are strong, and see how students can seamlessly move from getting their 2 year degree at MCTC, to attending Marshall.
- <u>Customer Relationship Management System</u>
  - This CRM system just implemented in admissions is coming on board.
  - It's system, called Slate, took some time to implement, but is now being led by our new CIO, Jodie Penrod.
    - This program will revolutionize our way of tracking students through the application funnel, and help get them admitted without too many steps along the way.

#### <u>Anthology</u>

- This company we are working with owns Blackboard, which we use in our classes.
- They will be helping us with enrollment management solutions as well by optimizing the application funnel.
- Online Programs
  - Online programs are coming into a High Flex format, which means that the faculty will teach live in the classroom, but will also have an online synchronous instruction for the same class as well as an asynchronous online program that will run with the same class being videotaped and seen by people later.
  - We are working on classroom technology and flexibility this semester with a pilot group, after which we will roll it out bigger based on the feedback.
- <u>**Q**</u>: Will you also be having a meeting with Bridge Valley?
  - <u>A:</u> Yes, we had a meeting in December, and we will have a meeting every month thereafter. They have a lot of great micro credentials and certifications they offer for the workforce development, and we want to collaborate with them as much as possible.
- **<u>Q</u>**: Is there a specific person tasked with leading the collaborations with the community colleges?
  - <u>A:</u> Yes. Transfer students are one of the 10 segments of students being recruited, and each segment has a champion for them, but we also need as many people from Marshall as possible helping.

# Matt Tidd - CFO

- Moody Bond Rating
  - Moody's Investor Services downgraded Marshall University's bond rating from A1 to A2.
    - This didn't come as a surprise, as declining enrollment played a big role in the decision.

- Marshall's decision to not raise our prices for several years was also a factor in the downgrade, but Marshall has an affordability mission that we want to continue.
- Controlling expenses was also a factor in the decision. We will be looking for creative ways to grow our revenue lines.

### Enrollment Impact

- Enrollment impacts our finances in the following way:
  - For every 100 students who come to Marshall, it equates to just over \$1,000,000 million.

### • Purchasing

- $\circ$   $\;$  It was announced some months ago that Finance would now oversee Purchasing.
  - Purchasing will become fully and appropriately staffed and get out in front of issues as opposed to being reactive.

# Bruce Felder – Human Resources

#### <u>Governor's Proclamation</u>

- In December, the governor issued a proclamation providing a ½ day holiday on December 23<sup>rd</sup> and December 30<sup>th</sup>. Marshall combined both half days to observe an additional holiday on January 3<sup>rd</sup>.
- The Governor then issued a proclamation changing Friday, December 23<sup>rd</sup> from a half day holiday to a full day holiday.
- We are left with a half day holiday, which will be observed on Friday, March 17<sup>th</sup>. The observation of the holiday will begin around noon.

#### • External Market Analysis

• We are working with payscale.com to benchmark all of our jobs to equivalent jobs in the market. This will be done for classified staff, non-classified staff, and faculty. This will allow us to know what the job should be getting paid, how far our employees are under market, and how much money we need to start planning for.

#### • Diversity, Equity and Inclusion

- Diversity, Equity and Inclusion (DEI) boils down to belonging.
  - Diversity is a fact, inclusion is a behavior, but belonging is an emotional outcome that people want in their organization.
- A DEI triad has been formed, consisting of Bruce representing staff, Cicero Fain representing faculty, and Marcie Simms representing students.
  - There has also been a DEI Advisory Council assembled, which will begin meeting the next day to start putting a plan together. The Council is led by Maurice Cooley, and also includes Montserrat Miller, Patricia Proctor, Ernest Morris, Shaunte Polk, David Cartwright, Georgianna Logan, Dr. Monica Brooks, Dean Bookwalter, Dr. Tim Melvin, Dr. Shelby Campbell, and Dr. April Fugett.

 This will involve creating a new department, the Center of Diversity, Equity and Inclusion and hopefully we will be able to create some micro credentials and certification programs.

# **Tracy Smith - Safety**

- After three long years since COVID started, the State of WV is ending the state of emergency due to COVID.
- We are transitioning from a pandemic to an endemic, and there will still be cases. The COVID-19 email address is still active, and sends automated replies but is also still monitored.
- Employees still need to let their supervisor know when they test positive.
- We are still following current CDC Guidelines of five days isolation, return on 6<sup>th</sup> day if no symptoms, and remain masked for five more days.
- Barriers in classrooms have begun to be removed, and work orders can be put in to take down office barriers.
- Masking has been reinstated in the hospitals due to the prevalence of RSV, Flu, and COVID.

# Sarah Payne – Associate VP for Government Relations

- The legislative session is in it's 7<sup>th</sup> day, and the following is what we are watching:
  - Campus Carry Bill President Smith from Marshall and President Gee from WVU put out a joint statement opposing campus carry. There are several versions of campus carry in the legislature, some of which have more considerations to limit guns in certain areas.
    - SB 10 has some of these considerations, including: guns wouldn't be permitted in areas or capacities over 1000 people, wouldn't be allowed at day care centers, wouldn't be permitted in any building used by law enforcement, wouldn't be permitted where colleges and universities have implemented security measures, wouldn't be permitted at hearings, workshops and labs with flammable substances, wouldn't be permitted at mental health counseling, in patient care, areas exclusively used by K-12 or private entities, areas prohibited by state or federal law. Guns would not be permitted in campus residence halls, except for common areas.
  - Autism Training Center Funding a request is in the governor's office for funding to build out the building and increase their services.
  - Deferred Maintenance the presidents are asking for collectively \$100 million to go to HEPC, to be split up between institutions.
- January 31<sup>st</sup> Marshall and WVU will hold a joint reception for the legislators to meet and greet, as well as focus on our efforts to expand workforce development and economic development.
- February 1<sup>st</sup> is Marshall Day at the Capitol.
- There had been 1138 bills introduced in the legislature, of which 32 mention higher education.
- A house bill was introduced to declare November 14<sup>th</sup> a special memorial day in remembrance of the Marshall University plane crash.
